The scope/description of the work is furnished here under.

SPECIFICATION OF T-GRID TYPE FALSE CEILING

Metal Framed Suspended Ceiling System

This ceiling system consists of G.I. "T" section and G.I. Furring Channel interlocked together at right angle to each other, using 6mm thick Hilux board with seamless finish.

Frame Work:

Precoated wall angles of size 25x25 mm are screw fixed to the perimeter of the wall at the given ceiling level. Main 'T' sections 3600mm long, with "H" slots at 150 or 300mm centres in its vertical flange, to hold the cross "T" sections, are suspended from the ceiling with the help of rawlplug, soffit cleat and G.I. wire(4mm dia) at 1200mm c/c. These sections also have notch at its both ends to increase the length. Cross "T" sections of 1200mm length with "H" slot in the centre and notches at both ends are inserted fixed into the main "T" at 600mm c/c to form a regular grid of 600x1200mm. Cross "T" of 600mm length is inserted fixed into the 1200mm cross "T" to form a regular grid of 600x600mm.

Board Laying:

Department pre-approved Ramco Hilux/Gyproc boards of size 595x595mm are to be laid into the grid depending on the metal grid size.

Note: Clamp down clips should be placed on the back side of the Hilux boards (at least 2 per sides)

General terms and conditions:

- 1. All the above works have to be carried out in presence of I.O/Station Head at Akashvani, Kumbakonam & Shivamogga.
- 2. The above works have to be carried out within 45 days from the date of issue of Supply/Work order.
- 3. Billing: The Additional Director General (E)(SZ), All India Radio & Doordarshan, Swami Sivananda Salai, Chennai-600005.
- 4. Terms of Payment: 100 % Payment on completion of work.
- 5. The quotation on the firm's letter head should be sent in a sealed cover addressed to The Additional Director General (E)(SZ), (By Name: R.TAGORENATH REDDY, DDE) All India Radio & Doordarshan, Swami Sivananda Salai, Chennai-600005.

- 6. THE COVER SHOULD BE SUBSRSCRIBED WITH THE FOLLOWING:
 - a) Work for which quotation is enclosed.
 - b) Reference to letter of enquiry.
 - c) Due date of opening quotation.
- 7. The Quotations will be opened in this office at 16.30 Hrs. on 25.04.2025 in the presence of tenderers or their agents such as they may choose to attend.
- 8. QUOTATIONS NOT PROPERLY SUBSCRIBED/NOT SUBMITTED ON THE FIRM'S LETTER HEAD WILL NOT BE CONSIDERED.
- 9. GUARANTEE / WARRANTY PERIOD:
 - The Work shall be guaranteed for a period of 1 Year from the date of Commissioning Any failure in the work carried out, during the Guarantee period shall be repaired / replaced free of charge by the Contractor at the Site.
- 10. Both your PAN and GST Number should be definitely indicated in your quotation.
- 11. Taxes: GST leviable and intended to be claimed from the purchaser should be distinctly shown along with prices quoted. Where this is not done no claim for GST will be admitted at any later stage and on any ground whatsoever.
- 12. The contractor shall make his own arrangement for storage of all equipment and materials brought to site from time to time and their safe custody at site till they are taken over by the indenter/his representative. The contractor shall make his own arrangement for providing accommodation for his workmen at site.
- 13. The contractor shall make his/her own arrangements for procuring necessary labour, skilled and unskilled. He should conform to all local government laws and regulations covering labour and their employment.
- 14. The contractor and his employees shall comply with the regulation in force for the controlled entry into premises where work is being carried out.
- 15. Contractor liable for damage caused during installation work and imperfections noticed.
- 16. The contractor shall indemnify and hold harmless the purchaser against all claims in respect of injury or life to any person howsoever arising out of the work in the course of such installation/work. The contractor shall discharge his entire obligation under the Indian Workmen Compensation Act in as for as it affects workmen in his employment.
- 17. Right of acceptance: The Additional Director General (E) (SZ), AIR & TV reserves the right to reject the lowest tender or all the tenders without assigning any reasons whatsoever. Further, the undersigned reserves himself the right for decreasing the quantity of material tendered depending upon the actual requirements. The unit rate quoted on the tender shall be applicable for the quantity for which order is placed.
- 18. The Additional Director General (E) (SZ), AIR & TV, Chennai also reserves the right to place **Repeat Order** for 50% or less quantity for which the quotation has been originally invited/order placed.
- 19.In case any item is found to be defective / substandard, the shall be rejected and no amount shall be paid for such items and such item shall be removed by the supplier from the site at his own cost.
- 20. The contractor shall get the **samples of material approved** sufficiently from the department. The material brought to the site shall strictly confirm to the quality of sample approved.
- 21. Payment shall be made as per the actual measurements.
- 22. **Experience**:- Tenderer should give documentary proof form having successfully completed of similar works (**Past experience**) in any Govt/public sector undertakings in the past. Failing this criteria, Bid will be rejected. Experience criteria should be mailed to dsp.air@rediffmail.com. Bids of those firm who have sent Experience criteria will be opened.
- 23. Firms who have already been awarded any tender by this office of value Rs.4 Lakh and above and is under execution and not being completed on the date of publishing of Tender are not eligible to participate in this tender.
