G.S.R. 893.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules, namely:—

MINISTRY OF INFORMATION AND BROADCASTING

G.S.R. 924.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the All India Radio (Class I Posts) Recruitment Rules, 1963, published with the Notification of the Government of India in the Ministry of Information and Broadcasting No. G.S.R. 24 dated the 23rd December, 1963, namely:—

1. These rules may be called the All India Radio (Class I Posts) Recruitment Second Amendment Rules, 1964.

(a) in the entries against Serial number 2,—

(i) in column 3. for figures "50", the figures "51" shall be substituted;

(ii) in column 8. after the existing entries, the following entry shall be inserted, namely:—

"Qualifications relaxable at the discretion of the Union Public Service Commission in the case of candidates otherwise well qualified.";

(b) in the entries against Serial number 3. in column 12, for the words "ordinary not exceeding", the words "not ordinarily to exceed" shall be substituted.
