CENTRAL EXCISES

New Delhi, the 6th May 1967

- G.S.R. 632.—In pursuance of sub-rule (2) of rule 49 of rule 139 of the Central Excise Rules, 1944, the Central Government hereby directs that the provisions relating to the removal of goods from one warehouse to another shall extend, subject to the conditions specified in paragraph 2, to Kerosens (Superior) produced according to the Aviation Turbine Fuel Specifications (hereinafter referred to as the said goods)
- 2. The said goods shall be permitted to be removed without payment of duty only-
 - (a) from the storage tanks of Messrs Indian Oil Corporation Limited (Marketing Division) or of Messrs Burmah-Shell Oil Storage and Distributing Company of India Limited, at their Installations at Tondiarpet (Madras) or of Messrs Esso Standard Eastern Inc. at their Installation at Korrukupet (Madras), licensed under rule 140 as warehouses, to their respective storage tanks similarly licensed at the oil installation at Meenambukkam Airport; and
 - (b) from one storage tank to another (of the same distributor) situated in the said installation at Meenambukkam Airport.

- G.S.R. 634.—In exercise of the powers conferred by the proviso to article 309 of the constitution, the President hereby makes the following rules further to amend the All India Radio (Class II Posts) Recruitment Rules. 1962, published with the Notification of the Government of India in the Ministry of Information and Broadcasting No. GSR 347 dated 6th March, 1962, namely:—
- 1. These rules may be called the All India Radio (Class II Posts) Recruitment (Amendment) Rules, 1967.
- 2. In the Schedule to the All India Radio (Class II Posts) Recruitment (Amendment) Rules, 1966,
 - (i) in column 2 of S. No. 15, for the words 'Radio Farm Officer' the words 'Farm Radio Officer' shall be substituted
 - (ii) in column 2 of S. No. 16, for the words 'Radio Farm Officer (Home)' the words 'Farm Radio Officer (Home)' shall be substituted.
