- G.S.R. 1563.—In exercise of the powers conferred by the provise to article 309 of the Constitution, the President hereby makes the following rules further to amend the All India Radio (Class I Posts) Recruitment Rules, 1963, published with the Notification of the Government of India in the Ministry of Information and Broadcasting No. GSR 24, dated the 23rd December, 1963, namely—
 - (i) These rules may be called the All-India Radio (Class I Posts) Recuritment (Second Amendment) Rules, 1967
 - (11) They shall come into force on the date of their publication in the Official Gazette.
- 2 In the Schedule to the All India Radio (Class I Posts) Recruitment Rules, 1963 after Serial No 3 and the entries relating thereto, the following shall be inserted, namely:—
