5. **Consolidated remuneration: Negotiable between Rs. 30,000 – 40,000/-**

6. **Eligibility Criteria:**

i. 10+2 from recognized board.

ii. Degree / Diploma in Cinematography from a recognized university/institute

9. **Nature of duties:**


