- d. The training period of Cost Trainees at Prasar Bharati would be extended for subsequent year based on yearly appraisals.
- e. Prasar Bharati reserves the right to conduct test and/ or interview of the shortlisted candidates. No TA/DA etc. will be paid for attending the test/ interview.


