2. 'A' certified films are not eligible for telecast on Doordarshan channels. Proposals in respect of only such films which are having 'U, VIU, U/A" and "V/UA certificates can be submitted for consideration. U/A or V/UA certified films can be telecast with cautionary endorsement that the question as to whether a child below the age of 12 years may be allowed to see such a film should be considered by the parents or the guardian of such child
3. Copy of link agreement(s), duly notarized on stamp paper, in order to establish that the applicant holds the rights of the film offered by him
4. Notarized copy of Censor Certificate.
5. Synopsis Including storyline, star cast and details of director, music director etc., list of hit song year of release.

8. Indemnity Bond in the prescribed formats

FURTHERMORE, that the 'Obligor' agrees to make available the film to the 'Obligee' by providing DVC Pro/DV Cam tapes for the purpose of preview and telecast or any other format prescribed by Doordarshan in course of time at his own expenses and it is mutually agreed that the same shall be returned to him after use.

4. FURTHER, that in the event of any objection / claim from any distributor/s or negative rights holder / Video rights holder or any party or parties against telecast of the above feature film 'the Obligor' agrees and undertakes to get the objections cleared of his own claim, litigation and / or dispute. The relevant documents in original will be produced for scrutiny as and when required by the Kendra.

5. FURTHER, that in the event of any dispute, this indemnity bond shall be subjected to the jurisdiction of appropriate Court in Bengaluru.

6. AND WHEREAS, the "Obligee" has expressed his willingness to give royalty to the 'Obligor' in connection with the telecasting of the Feature film \_\_\_\_\_ in \_\_\_\_\_ language over Doordarshan.
