7. Experience: At least 3 years in relevant field.


8. Age: Below 35 years as on date of notification.

Writing of News Stories, Editing of Visuals, Preparing the run down, Preparation of Graphic Elements, Tracking of developing News Stories, Conceptualizing, Scripting and overseeing Special Programmes, Editing and adding value to News reports filed by reporters.

10. The terms and conditions of the engagement are as given under:

- (i) The services will be purely on contractual basis. The persons engaged shall have no claim either implicit or explicit, for his/ her absorption or regularization in Prasar Bharati.

- (iii) Persons engaged will be working for both DD News (TV News) and All India Radio (Radio News) and will be simultaneously reporting to the RNU Head of DD News and RNU Head, AIR of respective region. Persons engaged on contract basis can be assigned additional task apart from the specific tasks for which they are engaged.
