

- **B.** This office takes no responsibility for delay, loss or non-receipt of quotations/documents sent by post where as reserves the right to accept or reject any part of the tender without assigning any reasons.
- **C.** Corrections if any must be attested. All rates shall be indicated both in words as well as in figures, where there is a difference between rates quoted in words and figures, rate quoted in words will prevail. The firm has to submit the signed copy of the Terms and Conditions along with the quotation. The submission is for the acceptance of the general terms and conditions without which the quote would be rejected.

F. QUOTATIONS VALIDITY:

Quotation should be valid for a minimum period up to 31 December 2023.

G. QUALIFYING BID:

The vendor may quote separate rates for accessories.

H. GURANTEE TERMS:

The supplier should provide warrantee/guarantee for minimum one years and onsite support. Any parts failing during the guarantee period shall be repaired /replaced free of charge by the supplier at the installation site.

I. Qualification Criteria

- 1. Bidder should have experience of minimum three years in the field of maintenance of water softening plant. Details of experience must be enclosed.
- 2. The bidder should have valid GST / PAN number. It is required to mention GST/ PAN number and must enclose copy of the registration without which bid would be rejected.

J. PRICE & STATUATORY DUTIES:

- 1. It should be mentioned specifically whether the price quoted includes all taxes and duties.
- 2. GST or other duties and levies where legally leviable and intended to be claimed should be distinctly and separately mentioned in the quotation. Where it is not done no claim for GST will be admitted at any later stage and no ground whatsoever.
- 3. GST registration No. and date of its validity should be mentioned.

- 4. Checking of all the parameters of the plant for proper working of softening plant.
- 5. Checking input/output water hardness in every service
- 6. Checking of reject pressure and feed pressure of water.
- 7. Checking of sensor, provided in soft water storage tank, for proper working

Six Monthly work

- 1. Cleaning of Resin as per requirement and add extra Resin if required.
- 2. Cleaning of regeneration water tank and soft water storage tank.
- 3. Raw water pump/Motor servicing and repairing (if required) at firm's cost.

In addition to above, if breakdown occurs, firm has to attend the problems on call basis as and when required.
