The necessary details are as under: -

- **1. Scope of work:** There are approximately 12000 invoices that are to be reconciled in r/o 19 DDOs for the Delhi state. GST Input Tax Credit reconciliation and matching for its 19 DDOs for the Delhi State between data as appearing in GSTR 2A and data as sent by DDOs for the financial year 2018-19.
- **2. Date & guidelines for submission of Bids**: Interested agencies are required to submit their quotations as per Annexure- I in sealed envelopes.

3. Eligibility criteria: -

- **a)** The Entity should be a registered CA/CA Firms having valid COP. The entity should have valid PAN issued by Income Tax Department.
- **b)** CA/ firms should have one full- fledged functional office in the Delhi/NCR region.
- c) The entity should not have been blacklisted for supply of any items or services to Doordarshan (Prasar Bharati) or any other Government department/agency in India. A self- declaration to be provided on forwarding letter of the quotation.

- **4. Evaluation of Bids: -** The financial Bids of those agencies will be considered that fulfill the eligibility criteria and have provided required documents.
- 5. The assigned work is to be completed within a period of 3 weeks (21 days) from the date of Award of Contract. The CA firm should furnish a certificate to the effect that the reconciliation work as per scope of this tender has been done as per Codal Provisions of GST.
- **6. Terms of payment: -** No advance payment will be considered. Payment for work will be made to the agency after satisfactory completion of work.
- **7. Earnest money:** The bidders must submit earnest money of Rs. 1000/- in the form of a demand draft/pay order issued by any Government scheduled/commercial bank in India in favour of Prasar Bharati (BCI), Doordarshan Commercial Service, New Delhi.

9. Other terms and condition:

- **10. Arbitration:** Venue of arbitration will be New Delhi and will be govern by provisions of the Indian Arbitration and Reconciliation Act.
- **11. Jurisdiction:** The contract shall be governed by all government rules, on purchase of goods/services, issued from time to time and in force are applicable to this contract tender.
- 12.
