Subject:-Contract for running canteen in Akashvani Bhawan, New Broadcasting House and Auditorium (On need basis), Parliament Street, New Delhi.

Directorate General: All India Radio invites two-year contract to run the canteen in Akashvani Bhawan, New Broadcasting House and Auditorium, Broadcasting House (On need basis) as per terms and conditions mentioned in annexures. Interested Tenderer/Firms fulfilling the following eligibility conditions are invited to submit their bid:-

- i) Tenderer/Firm should have experience of executing two successful contracts to their credit for running canteens in Government Departments, Public Sector Undertakings or Autonomous bodies having staff strength of 200 or more persons during the past 3 years or have 3 years of experience of successfully running restaurant in Delhi or other states. (Proof to be submitted)
- Tenderer/Firm Tenderer/Firm should have a minimum annual turnover of Rs. 10 ii) Lakh during the last 3 consecutive years, i.e. in the year 2016-17, 2017-18, and 2018-19. (Proof to be submitted)
- iii) Tenderer/Firm should have FSSAI registration/state license/central license. (proof to be submitted)
- iv) Tenderer/Firm should be having EPF and ESI registration certificates along with latest challans (certified copies of certificates and challans to be submitted)
- A Self attested copy of PAN Card/GST Registration Certificate of the bidding firms V) may be enclosed.
- Self-certificate that the firm has not been blacklisted by any Central Government vi) Ministry/ Department/PSU/Bank etc. should be enclosed.
- vii) The service providers should have their own Bank Account. (A certified copy of the account maintained for the last three years may be enclosed).



- 2. Tenderer/Firm may submit their e-tender in a two bid system i.e Technical bid as per Annexure-'B' and Financial Bid as per Annexure-'C-I' and 'C-II' latest by 03:00 PM on 20.12.2019. The bid should be accompanied with an Earnest Money Deposit (EMD) of Rs.60,000/- (Rupees sixty thousand only) in the form of Bank Draft/ FDR/Banker's Cheque drawn in favour of "PB(BCI), DG: All India Radio, New Delhi"
- 3. Tenders uploaded after the due date /time and /or not accompanied with Earnest money deposit and/or not accompanied with requisite documents, details shall not be considered at all by DG:All India Radio.
- 4. Tender will be opened online. The Eligibility Bids will be opened on the same day i.e. on 20.12.2019 at 04:00 PM. The position regarding opening of financial bids shall be intimated to the concerned tenderer in due course.

- 6. DG: All India Radio reserves the right to withdraw the tender at any stage or reject any or all the tenders without assigning any reason, whatsoever.

TERMS & CONDITIONS

- 1. The contract shall be governed by the terms and conditions to be laid down in an Agreement between this Directorate General and the successful tenderer to be executed on a stamp-paper of Rs. 100/-.
- 2. The contract will be initially for a period of two years from the date of signing of the contract and can further be extended with mutual consent maximum for one more year on the same price, terms and conditions.
- 3. The canteen is to be run from the designated premises in Akashvani Bhawan and Annexe canteen at New Broadcasting House. The successful bidder will also have to provide services on short notice at BH Auditorium as and when required.
- 4. Tenders uploaded after the due date /time and /or not accompanied with Earnest money deposit and/or not accompanied with requisite documents shall not be considered at all by DG: All India Radio. The incomplete, vague, unresponsive and late/delayed tenders will not be considered. A tender will be considered unresponsive where,
- (i) It is unsigned or signed without the rubber stamp of authorized signatory of the firm;
- (ii) It is illegible;
- (iii) It is not submitted as per Notice Inviting Tender and any of the terms and conditions;
- (iv) The quotation has not been made for all items;
- (v) The tender is conditional;
- (vi) The tenderer does not agree to any of the term and conditions specified herein;
- 5. All the required documents in support of the eligibility criteria along with scanned copy of EMD are also to be uploaded along with the bids. The bidders are advised, in their own interest, to submit the requisite papers/ documents with their bid as per specifications/eligibility criteria failing which their bids may be declared as non- responsive/ ineligible.
- 6. Late tenders will not be considered. No responsibility will be taken for any delay on account of non-submission of online bid on or before time. Bids sent by post/fax or email will not be considered and liable to be rejected.
- 7. The bidders should quote the rates for all items and note that the contract will be awarded only to one party on the basis of competitive and economical rates.

- 8. All concerned may read the Tender Document carefully before deciding to participate in the tendering process in this case. No correspondence, seeking any further details and clarifications, will be entertained.
- 9. This Directorate reserves the right to accept or reject any of the tenders without assigning any reason, whatsoever.
- 10. In case of any dispute/ disagreements so as to interpretation of any clause of otherwise, that may arise during or after the execution of contract, the matter shall be referred to arbitrators to be appointed/nominated by the DG: AIR whose decision regarding interpretation shall be final and binding on both the parties. The proceeding of arbitration shall be carried out in Delhi.
- 11. The successful bidder shall be required to deposit with DG: All India Radio, an amount of Rs. 1.50 Lakhs (Rupees One Lakh Fifty thousand only) as performance security deposit in the form of bank draft drawn in favor of "PB(BCI), DG: AIR" within seven days of commencement of the contract(s). The draft should be valid for 1 year and 3 months from the date of signing of the contract.
- 12. The said performance security deposit or part thereof shall be forfeited for any deficiency in service and/or breach of any of the terms and conditions of the proposed contract by the concerned successful bidder. In addition, penalty as deemed appropriate may be imposed on the concerned successful bidder in this regard. DG: AIR shall not accept any responsibility for any loss suffered by Contractor, and Bank Guarantee shall
- 13. The performance Bank Guarantee security submitted by firm shall forfeited if the firm withdraws the contract at any stage during the entire contract period.
- 14. DG, All India Radio reserves the right to terminate the contract after giving an advance notice of 30 days without assigning any reason whatsoever. DG: All India Radio also reserves the right to terminate the contract in case of unsatisfactory performance of bidder or on account of non-compliance of any term and condition of the contract or on account of violation of rules and regulations of the government.

REGISTRATION:

- (i) To participate in the e-tendering submission, it is mandatory for the Bidders to get registered their firm/joint venture with the e-tendering portal of AIR http://tenderwizard.com/PB to have user ID & Password form M/s ITI Ltd. The annual registration charges for vendor/supplier are Rs. 1180/- (Rupees one thousand one hundred eighty only).
- (ii) To participate in e-bid, bidders shall be charged e-tendering processing fee @ 0.1% of estimated contract value with minimum cap Rs. 590/- only and maximum cap Rs. 5900/- only
