



Sub: Decision taken in the conference of Financial Advisors-reg

DGS&D hosts an online Government e-Marketplace (GeM) for Goods and services commonly used by Government offices. Rule 149 of GFR provides that procurement of Goods and Services, by Ministries or Departments is to be mandatorily done through GeM, for Goods or Services available on GeM. The credentials of suppliers on GeM shall be certified by DGS&D and the procuring authorities will certify the reasonability of rates. This Rule also prescribes the detailed procedures for procuring goods and services through GeM Portal.

2. AS&FA, Ministry of Information & Broadcasting attended the conference of Financial Advisors chaired by Finance Secretary on 06.07.2017. It has been decided in the meeting that autonomous bodies also mandatorily procure through GEM goods and services which are available on the GeM Portal and there should be no violation of GFRs in this regard. It has also been decided that details of number of users service providers, orders placed (number and amount) and payment made in time or not should be reported.

3. In view of the above, all concerned are directed that all procurements in Prasar Bharati should be made as provided under Rule 149 of GFR-2017. When any item is not procured through GeM Portal, it must be certified by the wing which procured the item that the said item is not available on GeM Portal. If such a certificate is not furnished along with the bill, concerned DDOs shall not make payment against the bill.
