#### Akashvani Annual Awards (News), 2018

Nominations are invited for the following categories of Akashvani Annual Awards (News)- 2018

- 1. K. L. Sharma Award for Best Correspondent
- 2. Bold and Courageous Reporting Award
- 3. Best News Editor of the year Award
- 4. Best RNU Award
- 5. Best Newsreader Award

Guidelines for the awards are as follows:

#### 1. K. L. Sharma Award For Best Correspondent

- I. Eligibility: All correspondents
  - Regulars/Contractuals working across the country and abroad
  - Including Editors posted in one-man RNUs (who act as Correspondents)

- Filled pro forma to be submitted with Supporting Documents/Audio
- ADG (RNU), ADG (NR), ADG (Reporting) or the RNU Head may nominate candidates.

#### III. Criteria

- Correspondent should have made notable contribution towards National and Regional Bulletins, and Current Affairs Programmes- both in terms of in quality and quantity.
- Correspondent should be regular, prompt, consistent and objective in reporting news.
- S/he should have shown consistently outstanding performance.
- S/he should have taken initiative to report events and situations, which are off the beaten path.
- Correspondent should be able to bring out significance of atmosphere and other nuances of the story in a clear, lively, interesting and brief dispatch.
- Correspondent should be able to give a sharp overview and latest update in a live interaction so as to enrich a news story.
- Contribution to Social Media of RNU/NSD should have been done.
- At least 10 stories and 5 audios (Voice Casts) of each Correspondent need to be submitted for evaluation.

#### 2. Bold and Courageous Reporting Award

#### **I. Eligibility:** All correspondents

- Regulars/Contractuals working across the country and abroad
- Including Editors posted in one-man RNUs (who act as Correspondents)

- Filled pro forma to be submitted with Supporting Documents/Audio
- ADG (RNU), ADG (NR), ADG (Reporting) or the RNU Head may nominate candidates.

#### **III. Criteria:** In addition to above given criteria for Best Correspondent Award:

- Correspondent should have reported from an area where threat to life is involved. For example, reporting during war or national calamity, in a conflict area, etc.
- Correspondent should have reported from an area where it is difficult to establish communication and/or not easy to move freely.
- Content of coverage should be of uncompromising nature, without succumbing to pressures of the environment, and other outside pressures.
- Contribution to Social Media of RNU/NSD will also be taken into account.
- At least 10 stories and 5 audios (Voice Casts) of each Correspondent need to be submitted for evaluation.

# 3. Best News Editor of the year Award

#### I. Eligibility: All Editors

- Regulars/Contractuals working across the country and abroad
- Including Correspondents working as Editors (Single officer unit)
- NRTs working in Hindi News room who have continuously worked as Editors will also be considered

- Filled pro forma to be submitted with Supporting Documents/Audio
- ADG (RNU), ADG (NR), ADG (Reporting) or the RNU Head may nominate candidates.

#### III. Criteria

- The editor should have made notable contribution towards National /Regional News Bulletins or News-Based Programmes- both in terms of quality and quantity.
- The editor should have contributed towards improving content of the News Bulletin/News Based Programmes by adding appropriate sound inputs, and through the selection of proper stories/subjects for news based programmes.
- Innovative ideas for improving the bulletin will be taken into consideration.
- The editor should be regular, prompt, consistent and objective in his/her work.
- S/he should have shown consistently outstanding performance.
- The editor should have taken initiative for inclusion of important items/subjects in the news bulletins/news based programmes, even against odd circumstances.
- 10 stories edited by him/her along with their sources need to be evaluated.

#### 4. Best Regional News Unit

**I. Eligibility:** All RNUs working across the country will be eligible for consideration for the award.

- Filled pro forma to be submitted with Supporting Documents/Audio
- **III. Criteria:** The following will be considered:
  - Initiatives taken by RNU in order to improve News Bulletins/News Based Programmes.

- Initiatives taken to expand news programming at the RNU by mounting Special Programmes on important events, beyond the regular Fixed Point Chart (FPC) of the station.
- Initiatives taken by RNU to increase listener-ship of its News Bulletins/News Based Programmes.
- Efforts made for better functioning of RNU including improvement of physical infrastructure and technological up-gradation, and use of technology.
- Additional inputs provided/initiatives taken against odd circumstances by RNU.
- Expansion of existing programmes and/or introduction of new programmes by RNU, in addition to existing ones.
- Efforts made by RNU to utilize funds earmarked under Station's budget for strengthening regional news.
- Efforts made by RNU to maximize output of PTCs in the state and monitoring their performance.
- Efforts made by RNU to work as a cohesive unit.
- Contribution to Social Media of NSD and RNU.

#### 5. Best Newsreader Award

I. Eligibility: The Award is open to Regular and Contractual
Newsreaders/NRTs working in NSD and RNUs of any language in which news
bulletins are broadcast

- Filled pro forma to be submitted with Supporting Documents/Audio
- ADG (RNU), ADG (NR), ADG (Reporting) or the RNU Head may nominate candidates.

#### **III. Criteria:** The News Reader/NRT should:

- Have made notable contributions towards national and regional bulletins, features and current affairs programmes.
- Be regular, prompt, consistent and objective in news reading/translation/anchoring.
- Should have shown consistently outstanding performance.
- Be familiar with modern communication tools.
- Be prompt in delivery of News Bulletins and Current Affairs programmes.
- Any special assignment may also be mentioned.
