The following amendments to above referred A/T are hereby authorized:

CLAUSE 7: DATE OF DELIVERY: -

You have failed to deliver the entire quantity of stores within the delivery period which expired on 20/09/2019.

In view of circumstances stated in your letter dated **17/09/2019**, Date of Delivery under Clause 7 of AT is extended **up to 30/11/2019**. Subject to the following conditions: -

Subject to the Extension of Security Deposit up to 30.01.2023


1. Please note that an Amount equal to the liquidated damages for the delay in supply of stores after the expiry of the contract delivery period shall be recovered from you as specified in Clause 11 (a), of Annexure II, General Terms and Conditions of the Tender document. As specified in this clause, an amount equivalent to **½% (half percent)** of the contract price of whole unit per week or part therefore subject to maximum of **10% (ten percent)** of the contract price of the whole unit of stores which the contractor may fail to deliver within the period fixed for delivery shall be recovered as liquidated damages. Stores, if any already tendered by you for inspection but not inspected will now be inspected accordingly.
2. The above extension of delivery date will also be subjected to the following further conditions:-
 - a) That no increase in price on account of any statutory increase in or fresh imposition of Customs Duty, Excise Duty, Sales Tax or on account of any other Tax or Duty livable in respect of stores specified in the said A/T which takes place after **20.09.2019** shall be admissible in such of the said stores as are delivered after the said date.

b) That notwithstanding any stipulation in the contract for increase in price on any other ground, no such increase which takes place after **20.09.2019** shall be admissible on such of the said stores as are delivered after the said date.

c) But nevertheless the purchaser shall be entitled to the benefit of any decrease in price on account of reduction or in revision of custom duty, excise duty, sales tax or on account of any other Tax or Duty or on any other ground as stipulated in the price variation clause which takes place after the expiry of the above mentioned dated namely **20.09.2019**.

3. You are requested to note that notwithstanding the provisions in delivery period the time is hereby extended for supply of stores shall be deemed to be essence of contract and failure on your part to supply the stores by the extended time shall entitle the purchaser to cancel the contract at your risk and cost without further notice or opportunity.

4. All other terms and conditions of AT remain unchanged. Kindly acknowledge the receipt of this amendment letter.
