

Subject: Implementation of New Security Features in PFMS

In order to ensure safety measures on PFMS platform, the following features are being enforced for treasury operations with immediate effect:-

1. A bill shall not be allowed to be passed at all the three levels in Pay & Accounts Office viz. Dealing Hand, Asstt. Accounts Officer and Pay & Accounts Officer using same I.P. address. (All non-NIC-network users to migrate to VPN with immediate effect. The procedure for obtaining NIC-VPN was already circulated vide this office O.M. No.MF-CGA/ITD-SPC/2018-19/VPN Connectivity/2652 dt 07-02-2019. The requirement for same was also reiterated vide this office O.M. No. MF-CGA/ITD/SDTQC/SM/2019-20/128/1164-71 dated 16-08-2019.)
2. All approved user IDs will now be activated in PFMS after passage of 24 hours from approval time stamp.

All Pr. CCAs/CCAs/CAs with independent charge are requested to guide the users accordingly.
