
2. The above financial up-gradation shall be purely personal to the official concerned and shall have no relevance to his/her seniority position.

3. On up gradation, the pay of these officers shall be fixed under the provisions of FR22(I)(a)(1). The financial benefit allowed under the scheme shall be final and no pay-fixation benefit shall accrue at the time of next regular/ad-hoc promotion.

4. Head of Kendras are supposed to re-check and verify the service particulars in respect of these officers scrupulously before the order of pay fixation is issued. In case of retired officers, pension may be re-fixed accordingly. It is also directed that Head of Office may not examine and issue his/her own order of pay fixation. A copy of the order issued in this regards may be sent to this Directorate for records. In case of any doubt, refer the matter immediately to the Directorate for clarification before pay fixation.

5. The above financial up-gradation and subsequent pay fixation will further be subject to the following:-

- any order/judgment of Tribunal/Court affecting the ACP/MACP granted;
- any present/subsequent directions issued by MIB /Prasar Bharati/DG:AIR/DG:DD; and


