The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". - 11. SC/ST contractors enlisted under class V category are exempted from processing fee to ITI Limited.
