The Assistant Engineer (Electrical), Civil Construction Wing, All India Radio, SRFTI, Kolkata – 700 0094 invites on behalf of the President of India online item rate tender on single bid system from approved and eligible contractor of CPWD / MES / BSNL / Railway / West Bengal State PWD for the work as follows:

- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website [www.tenderwizard.com/AIR](http://www.tenderwizard.com/AIR) free of cost.
- But the bid can only be submitted after uploading the mandatory scanned documents such as Certificate of work experience/Credential, proforma for earnest money deposit declaration and processing fee in favour of ITI limited. Goods & service tax registration & other documents as specified.

**e-Tender Processing Fee – Rs. 590,00** to be paid through E-Banking to ITI Limited

A part of earnest money is acceptable in the form of bank guarantee also. In such case, minimum 50 % of earnest money or Rs.20 lacs, whichever is less, shall have to be deposited in shape prescribed above, and balance may be deposited in shape of Bank Guarantee of any scheduled bank having validity for 6 months or more from the last date of receipt of bids should be deposited either in the office of Executive Engineer inviting bids or division office of any Executive Engineer, CCW, AIR within the period of bid submission. The same should also be scanned and uploaded by the intending bidders. (The bank guarantee as EMD should only be issued from the place in which the office of receiving division office is situated). The EMD receiving Executive Engineer shall issue a receipt of deposition of EMD to the bidder in a prescribed format uploaded by tender inviting EE in the NIT.

This receipt of deposition of bank guarantee shall also be uploaded to the e-tendering website by the intending bidder upto the specified bid submission date and time.

## ANNEXURE-A

Copy of Enlistment Order and Certificate of work experience and other documents as specified in the notice shall be scanned and uploaded to the e-tendering website within the period of bid submission. However, certified copy of all the scanned and uploaded documents as specified in notice shall have to be submitted by the lowest bidder only within week preceding the office of tender opening authority.

### Proforma for earnest money deposit declaration

Whereas, I/we ..... (name of agency)..... have submitted bids for .....(name of Work).....

I/We hereby submit following declaration in lieu of submitting Earnest Money Deposit

- (1) If after the opening of tender, I/we withdraw or modify my/our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents,
- or
- (2) If, after the award of work, I/we fail to sign the contract, or to submit performance guarantee before the deadline defined in the tender documents,

I/we shall be suspended for one year and shall not be eligible to bid for Civil Construction Work. All future tender bids from date of issue of suspension order.

5. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If awarded the, can be imparted training on online bidding process as per details available on the website.
6. The intending bidder must have valid class-III digital signature to submit the bid.
7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
8. Contractor can upload documents in the form of JPG format and PDF format.
9. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue.  
In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0".  
Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
10. SC/ST contractors enlisted under class V category are exempted from processing fee to 1% limit.
11. Online bid documents shall be opened only of those bidders, whose Earnest Money Deposit, or Bid Processing fee and other documents are found in order.
12. The department reserves the right to reject any prospective application without assigning any reason and to reject the bid of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the bid document stipulation.
13. The system of uploading the scanned documents for financial instrument such as Demand Draft or Fixed Deposit or Cheque or Deposit at call receipt or Fixed Deposit receipts and Bank Guarantee of any Government/PSU/State Bank or Co-operative Bank in favour of respective Executive Engineer and processing fee in favour of 1% limit is discontinued with immediate effect since the available menu for financial instruments has been modified.
14. The intending bidder has to fill all the details of Demand Draft/Fixed Deposit Receipt/Any Cheque/Bank Guarantee, name, amount, number and date) against bid processing fee.

The certified copy of all the scanned and uploaded documents specified in the tender notice shall be deposited by me/us with the Executive Engineer calling the tender in case I/We become the lowest tenderer within a week of the opening of the financial bid otherwise the department (CCW,AIR) may reject the Tender and take the action to Debar me/us from Tendering in CCW,AIR , for a period of three years and can write to the Competent Authority for cancellation of my/our enlistment (Original papers of the uploaded documents shall be shown for verification.

**15. NIT CONDITIONS:-**

- I. The GST has been implemented by the Government of India with effect from 1<sup>st</sup> July 2017. The rates quoted by the tenderer shall be firm and inclusive of all taxes including GST.
- II. Tenderer shall examine the various provisions of CGST Act, 2017/ IGST Act, 2017/UGST Act 2017/SGST Act 20-17 of the respective state and upto date amendments issued from time to time and other applicable taxes before bidding/tendering. The tenderer shall also confirm to the rules made under these Acts.
- III. The tenderer shall ensure that benefit of input tax credit (ITC) likely to be availed by them is duly considered by them while quoting rates.
- IV. The contractor shall submit the invoice of the work executed as per rule 35 of CGST Rules 2017.
- V. As contractor's rates are inclusive of all taxes, no reimbursement of any tax shall be made to the contractor. The clauses 37 of GCC of NIT/contract stands modified accordingly.
- VI. TDS on income tax, labour cess and other statutory deductions shall be made at source as per prevalent laws. TDS on GST as & when becomes applicable will also be deducted as per relevant GST Act/rules/notification.
