



4. Contractor can upload documents in the form of JPG format and PDF format.
5. Firms/ agency must ensure to quote rate of bid. The column meant for quoting rate in figures appears in pink color and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
6. The Department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any numbers deemed suitable by it, if too many bids are received satisfying the laid down criterion.
