- The intending bidder must read the terms and condition of CPWD 6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and instructions for bidders posted on web site shall form part of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/AIR free of cost and also in www.tenderdetail.com
- Those contractors not registered on the website mentioned above, are required to get registered beforehand.
- If needed they can be imparted training on online bidding process as per details available on the Website
- The intending bidder must have valid class-III digital signature to submit the bid.

7. Contractor can up load documents in the form of JPG format and PDF format.
8. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in Yellow colour and the moment rate is entered, it turns Green.
In addition to this, while selecting any of the cells a warning appears that if a any cell is left blank the same shall be treated as "0".
Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO)
9. The prices quoted by the tenderer shall be firm for the entire contract period. Prices shall be inclusive of all taxes and duties including GST as applicable.

2. Enlistment Order of the contractor and Electrical Inspectorate certificate.

9. GST Registration certificate of the State in which the work is to be taken up, if already obtained by the bidder alongwith upto date GST return in Annexure-3B (latest)

If the bidder has not obtained GST registration as applicable then he shall scan and upload following undertaking along with bid documents.

" If work is awarded to me, I/we shall obtain GST registration certificate as applicable within one month from the date of receipt of award letter or before release of any payment by CCW, whichever is earlier, failing which I/we shall be responsible for any delay in payments which will be due towards me/us on account of the work executed and/or for any action taken by CCW or GST department in this regard".
