## TERMS & CONDITIONS :

- The service is purely on contract basis. No claim for any employment in this department shall be entertained. The agency will be responsible for monthly payment to the engaged personnel as per minimum wages act, of Govt.of Odisha within 10<sup>th</sup> of the following month of duty <u>'On no work no</u> <u>Pay Basis'</u>.
- 2. The candidate should be a certificate holder on Computer operating (Preferably should know MS office, MS Excel & Internet) from a Computer Training Institute.
- 3. The Contract period will be 03 (Three) months only.
- 4. The contract can be terminated at any time without assigning any reasons.
- 5. No accommodation will be given from the department for the engaged personnel.
- 6. The payment will be made monthly to the agency on submission of bill after deducting TDS as per prevalent Govt. Rules, after the work done satisfactorily.
