1. Intending bidders

(a) Should have satisfactorily completed the works as mentioned below during the last Seven years ending last day of the month previous to the one in which the tender is Invited.

(i) Three similar work each of value not less than 40 % of the estimated cost put to tender

Or

- (ii) Two similar work each of value not less than 60 % of the estimated cost put to tender \mathbf{Or}
- (iii) One similar work of value not less than 80 % of the estimated cost put to tender (at least one of them should be in Central Govt./ Central Autonomous body, Central Public Sector Undertakings)

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7 % per annum, calculated from the date of completion to the last date of receipt of application for tender.

- 2. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is possession of all the documents required.
- 3. Information and Instruction for bidders posted on website shall part of bid document.
- 4. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/AIR free of cost.
- 5. But the bid can only be submitted after **depositing Processing Fee in favour of ITI Limited** and uploading the mandatory scanned documents such as Demand Draft or Pay order or Banker's Cheque or deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards EMD in favour of respective Executive Engineer (E), CCW, AIR, Kolkata and other documents as specified.
- 6. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website.
- 7. The intending bidder must have valid class-III digital signature to submit the bid.
- 8. On opening date, the contractor can login and see the bid opening process. After opening of bids he

will receive the competitor bid sheets.

9. Contractor can upload documents in the form of JPG format and PDF format.

10. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate entered, it turns sky blue. In addition to this, while

selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (**ZERO**).

- 11. SC/ST Contractors enlisted under class V category are exempted from processing fee payable to ITI Limited.
- 12. Earnest Money in the form of Treasury Challan or Demand Draft or Pay order or Banker's Cheque or Deposit at Call Receipt (drawn in favour of **Executive Engineer (E), CCW, AIR, Kolkata**) or Bank Guarantee of any Scheduled Bank and its receipt copy shall be scanned and uploaded to the e-tendering

website within the period of tender submission.

- 13. A part of earnest money is acceptable in the form of bank guarantee also. In such case, 50% of earnest money or Rs. 20 lac, whichever is less, will have to be deposited in shape of prescribed above, and balance in shape of Bank Guarantee The original EMD should be deposited to the office inviting bids within the period of bid submission. The receiving office shall issue a receipt of deposition of Earnest Money Deposit to the bidder in a prescribed format (Enclosed). This receipt shall also be uploaded to the e- tendering.
- .14. Interested contractor who wish to participate in the tender has also to make following payments in the form of Demand Draft/ Pay Order/ Banker's Cheque of any scheduled Bank and to be scanned and uploaded to the e-Tendering website within the period of tender submission:
 (i) E-Tender Processing Fee Rs.**590.00** to be paid through E-Banking to ITI Limited.
- 15. Treasury Challan or Demand Draft or Pay Order or Banker's Cheque or Deposit at Call Receipt or FDR or Bank Guarantee against EMD should be deposited to the office inviting bids within the period of bid submission and receipt of the same shall also be uploaded to the e- tendering along with Copy of Enlistment Order and Certificate of work experience as required within the period of tender submission.
