- 3. Joint Ventures are allowed in case of Central/State Government Undertaking.
- 4. The bid document consisting of specifications, schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from the website www.tenderwizard.com/AIR free of cost.
- 5. The bid can only be submitted after depositing Processing Fee in favour of M/s.
