- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/AIR free of cost.
- (i) The bidder should scan and upload the documents for financial instruments, such as Demand Draft or Pay order or Banker's Cheque or Deposit at call receipts of any schedule bank towards EMD in favour of **PB, BCI, EE(C) MHP Division, New Delhi** and e-tender processing fee as admissible shall be payable to M/s ITI Limited through e-gateway by Credit Card/Debit Card, Internet Banking or RTGS/NEFT facility.
 ii) The amount of EMD can be paid by Demand Draft/Pay Order /Banker's Cheque /Deposit at call receipt /FDR's of any schedule bank.
 iii) **Detailed procedure can be seen in the CPWD -6 for e-tendering.**
- Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
- The intending bidder must have valid class-III digital signature to submit the bid.
- On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- Contractor can upload documents in the form of JPG format and PDF format.

9. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
10. The contractor shall quote rates including work contract GST, other taxes, Cess and levies. However, GST shall be reflected in the tax invoice / bill separately.
11. Receipt of Deposition of EMD - -As per NIT-
11. **List of Documents to be scanned and uploaded within the period to tender submission.**
- i) Dement Draft/Pay order or Bankers Cheque / Deposit at Call Receipt/FDR of any Schedule Bank against EMD.
- ii) Affidavit as per clause – 9 of form CPWD-6 on non judicial stamp paper of Rs.100/- duly notarized.
- iii) Enlistment order / valid registration of the contractor.
- iv) Certificate of registration of GST.
- v) Scanned copy of Earnest Money and receipt of deposition of Earnest Money. (It is mandatory to upload scanned copies of all the above cited documents. If, one of these documents is not uploaded, then bid will become invalid and shall summarily be rejected).

The bidder shall be required to produce original documents for verification on demand by Assistant Engineer (Civil).
