- 4. (i) The bidder should scan and upload the documents for financial instruments, such as Demand Draft or Pay order or Banker's Cheque or Deposit at call receipts of any schedule bank towards EMD in favour of PB, BCI, EE(C) MHP Division, New Delhi and e-tender processing fee as admissible shall be payable to M/s ITI Limited through egateway by Credit Card/Debit Card, Internet Banking or RTGS/NEFT facility.

 of bids he will receive the competitor bid sheets.

Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0".

Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item

The contractor shall quote rates including work contract GST, other taxes, Cess and

levies. However, GST shall be reflected in the tax invoice / bill separately.
