- 10) If the workman ship is found to be unsatisfactory the undersigned reserves the right to terminate the Contract without assigning any reason.

- 12) The quotation will be opened in office at 15.30 hrs. on 30 / 10 / 2018. in the presence of such tenderers or their agents as may choose to attend.

- 18) While engaging labour for carrying out obligations under contract, the contractor shall satisfy the conditions laid down under contract labour ( Regulation and Audition Act 1970 and Central)Rule 1971 as Amended from time to time and Observe the provision under minimum wages Act1948(Central) Rule 1950 amended from time to time while engaging labour.
- 19) The contractor shall indemnify and hold harmless the office all claims in respect of injury to any person howsoever arising out of the work in the course of maintenance work .The contractor shall discharge his entire obligation under the Indian Workman Compensation Act in as it affects workmen In his Employment.
