## **ANNEXURE-B**

### **ADDITIONAL SPECIAL TERMS AND CONDITIONS:-**

01. The scope of work in this maintenance is providing required Labour for attending day to day Maintenance assigned by Engineer in charge.
02. Dismantled materials shall be the property of department.
03. The work is to be executed in general shift from 9 AM to 6 PM with admissible lunch break, however the shift timings are subject to change if required by the Engineer in charge.
04. .Age limit of all staff should be in between 18 to 60 years.
05. The name and address of the staff employed for operation is to be communicated to the AE(C) and AE(C)(P).
06. Alternative arrangements shall have to be made by the contractor during leave period of a particular person so that the continuity of service is maintained during such leave period.
07. Necessary register has to be maintained by the contractor for receipt and issue of materials as per the Instruction of AE(C)(P) and should be submitted to AE(C)(P) periodically.
08. Cost of any loss or damage to the material issued by the Department free of cost and cost of dismantled material not returned by the contractor shall be assessed by AE(C)(P) and the same shall be recovered at doubled such assessed value.
09. No room/residential accommodations or TA/DA for the laborer shall be provided by the department.
10. Contractor shall make contribution towards EPF and ESI what so applicable as per the existing labour contract rule. Contribution on the part of the employees shall also be paid and it will be reimbursed by the contractor .Department after satisfying that is has been actually and genuinely paid by the contractor i.e. on production of relevant receipt. The department shall not take any responsibility whatsoever on dispute of payment to the EPF and ESI.
11. Any applicable tax and claimed / intended to be claimed from should be distinctly shown along with amount quoted. Where this is not done, no claim for taxes will be admitted at any later stage and on any ground whatsoever. Service Tax, if applicable to be borne by the contractor himself.
12. The contractor shall comply with all the provisions of minimum wages act, 1948, and contract labour (Regulation and Abolition) act 1970, amended from time to time and rules framed there under and other labour laws affecting contract labour that may be brought into force from time to time

### **SAFETY/ INSURANCE**

- i) All safety precautions as laid down in the CPWD specification and other standard specifications shall be observed by the workers employed by the contractor at his own cost.
- ii) The Department shall not be liable for payment of any compensation in whatever form for accidents or Damages which may occur to any of the workers or to a third party during the course of execution of any work under the terms and conditions of this contract the contractor is therefore advised to take of this suitable insurance cover at his cost for this purpose to cover all the risks.

TERMS OF PAYMENT

- i) The Full payment shall be made within reasonable time depends on receipt of the same from user/Client Department.
