- 3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website <a href="https://www.tenderwizard.com/AIR">www.tenderwizard.com/AIR</a> free of cost.
- 4. (i) The bidder should scan and upload the documents for financial instruments, such as Demand Draft or Pay order or Banker's Cheque or Deposit at call receipts of any schedule bank towards EMD in favour of PB, BCI, Executive Engineer(C) MHPD, CCW, AIR, New Delhi and e-tender processing fee as admissible shall be payable to M/s ITI Limited through their e-gateway by Credit Card/Debit Card, Internet Banking or RTGS/NEFT facility.
  - ii) The amount of EMD can be paid by Demand Draft/Pay Order /Banker's Cheque /Deposit at call receipt /FDR's of any schedule bank.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
- The contractor shall quote rates including work contract GST, other taxes, Cess and 10. levies. However, GST shall be reflected in the tax invoice / bill separately.
