

OFFICE MEMORANDUM

Subject: Publishing of user charges on the Department website as per Rule 47 of GFR 2017 - regarding.

The undersigned is directed to refer to this office O.M. No. Pr.AO/B&A/Misc./2016-17/369 dated 26th May, 2017 and subsequent O.M. No. Pr.AO/B&A/User Charges/2016-17/1432 dated 15th October, 2018, wherein detailed instructions for levying of User Charges by the Ministry/Department w.r.t. rules 47 of GFR, 2017 were issued. "It stipulates that 'User Charges' is an important component of the non-tax revenue and each Ministry/Department may undertake an exercise to identify 'user charges' levied by it and publish the same on its website".

2. Further, reference of Rule 229 of GFR, 2017 dealing with Autonomous Organizations regarding maximizing generation of internal resources and eventually attain self-sufficiency were also made. It stipulates that Governing Body of the Autonomous Body shall review user charges/sources of internal revenue generation at least once a year and inform the administrative Ministry. This exercise should preferably be completed before the formulation of Union Annual Budget.

3. Expenditure Management Committee (EMC) in its report on improving processes has recommended that each Ministry/Department may undertake an exercise to identify the user charges levied and publish the same on its website, it should be periodically reviewed and be linked with appropriate price indices.

4. In the above context, it is stated that no information has been received so far. It is, therefore, reiterated that instruction contained in above referred O.M. dated 26th May, 2017 may be adhered to, and action taken in this regard may be intimated to this office immediately.
