- 2.1 100 Mbps connectivity point to point leased circuit on uncompressed, unshared leased line (1:1) at NSD:AIR, New Broadcasting house, All India Radio, Parliament street, New Delhi on rental basis. This includes setting up of last mile Connectivity, Supply, Installation, Commissioning, Testing, laying of cable up to Ethernet port & up keep of the complete link. - 10.9 ISP or authorized person from ISP will be required to sign Service Level Agreement.

10.12 The bidder shall restore the original condition of any Civil/Electrical infrastructure after carrying out any such work required to make the ILL fully functional.

11 TERMS & CONDITIONS:

- 11.1 Contact Period: This contract between NSD:AIR Delhi and Bidder shall be valid for a period of Three years from the date of successful implementation of the Internet Connectivity. The contract can be extended after three years, if service provided by the firm is satisfactory, for maximum two years (one year at a time) on mutual agreement with the same rate, terms & condition.
- 11.2 Delivery Period: The bidder shall complete the work within 30 days from the date of award.
- 11.3 Service and Support: All the hardware required for providing this ILL fully furnished shall be in 1+1 mode. The bidder shall provide 24x7 services. In case the down time is more than the specified limit, NSD:AIR Delhi reserves the right to deduct the Liquidity Damage amount monetarily in proportion of excess of down time accumulated to its total time over to quarterly access charges at the end of a quarter. The counting time of down time will begin from the moment the link goes down till revival of connection.

11.4 Planed Downtime

There shall however, be a provision for planned maintenance activity in the service provider's network for which the service provider shall inform NSD:AIR Delhi at least 5 working days in advance. NSD:AIR Delhi will access the feasibility for such a downtime and allow the same. The maximum window for such maintenance shall not exceed 4 hours in six months with a single block not exceeding 2 hours at a stretch. The downtime period taken for planned maintenance activity shall not be reckoned for calculating the Uptime availability of the services.

- **11.5 Maintenance:** Complete maintenance of the Internet services up to NSD:AIR premises shall be sole responsibility of the bidder. NSD:AIR Delhi will not be responsible for any kind of damage of hardware / software mentioned above.
- **11.6 Price Reduction:** If there is any trend of reduction in lease bandwidth charges in India as per TRAI guideline /Government notification, proportionate reduction in rental charges shall be done for AIR Delhi by the bidder.
- **11.7 Payment terms:** No advance payment shall be made. The payment will be made on post quarterly basis on submission of invoice with requisite details of payments being claimed.
- 11.8 NSD:AIR reserves the right to verify/seek confirmation of all original documentary evidence submitted by bidders in support of above mentioned specification for eligibility criterion. In case any information furnished by the bidder is found to be false/ incorrect at any stage, the bid shall be summarily rejected and no correspondence on the same shall be entertained.

13. Arbitration:

All the arbitration proceedings shall be conducted in English and in accordance with the Arbitration and Conciliation Act, 1996 as amended from time to time and the decision of the Arbitrator shall be final and binding. Each party shall bear its own costs and equally share the fees of the Arbitrator unless Arbitrator decides otherwise.
- **13.2 Jurisdiction**: All disputes arising from the contract shall be subject to the exclusive jurisdiction of the courts of Delhi.
- 13.3 Governing Law: The agreement will be governed in all respect by the Laws of India.

14 Termination of contract:




