G.S.R. 1791.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the All India Radio (Class I Posts) Recruitment Rules, 1963, published with the notification of the Government of India in the Ministry of Information and Broadcasting No. G.S.R. 24, dated the 23rd December, 1963, namely:—

1. (1) These rules may be called All India Radio (Class I posts) Recruitment (Second Amendment) Rules, 1968.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the All India Radio (Class I posts) Recruitment Rules, 1963, after Serial No 10 and the entries relating thereto, the following shall be inserted, namely:—
