सा. का. नि. 83:—संविधान के अनुच्छेद 309 के परंतुक द्वारा प्रदत्त शक्तियों का प्रयोग करके हुए राष्ट्रपति, एतद्वारा, भारत प्रतिभूति मुद्रणालय और करेंसी नोट प्रैस (वरिष्ठ सुरक्षा अधिकारी और सुरक्षा अधिकारी) भर्ती नियम, 1995 में और संशोधन करते हुए निम्नलिखित नियम बनाते हैं, अर्थात्:—

1. (1) इन नियमों को भारत प्रतिभूति मुद्रणालय और करेंसी नोट प्रैस (वरिष्ठ सुरक्षा अधिकारी और सुरक्षा अधिकारी) भर्ती (संशोधित) नियम कहा जाएगा।

(2) ये सरकारी राजपत्र में उनके प्रकाशन की तारीख से प्रवल होंगे।

New Delhi, the 31st January, 1997

G.S.R. 93.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the All India Radio (Group 'C' posts) Recruitment Rules, 1964, in so far as they relate to the post of Motor Drivers, except as respect things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of Recruitment to the posts of Staff Car Drivers in the Directorate General, All India Radio and Doordarshan, Ministry of Information & Broadcasting, namely :—

1. Short title and commencement.—(1) These rules may be called the All India Radio|Doordarshan Staff Car Drivers (Group 'C' posts) Recruitment Rules, 1997.

(2) They shall come into force from the date of their publication in the official Gazette.

2. Initial Constitution.—The incumbents who have been appointed on regular basis before the commencement of these rules, will be deemed to be appointed under these rules and their service will be counted for the promotion.

3. Number of posts, classification and scale of pay.—The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

4. Method of recruitment, age limit, qualifications etc.—The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in Columns 5 to 14 of the aforesaid Schedule.

5. Disqualifications.—No person,—

- (a) who has entered into or contract a marriage with a person having a spouse living; or
- (b) who having a spouse living, has entered into or contracted a marriage with any person ; shall be eligible for appointment to the post service.

Provided that the Government may, if satisfied that such marriage is permissible under the personal Law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax.—Where Government is of the opinion that it is necessary or expedient so do, it may by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving.—Nothing in these rules shall affect reservations and other concessions, required to be provided for persons belonging to the Scheduled Castes and Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government from time to time.


