**MINISTRY OF INFORMATION AND BROADCASTING***New Delhi, the 23rd December 1963*

**G.S.R. 24.**—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the notification of the Government of India in the Ministry of Information and Broadcasting No. S.O. 1064 dated the 26th May, 1958, the President hereby makes the following rules, namely:—

1. **Short title.**—These rules may be called the All India Radio (Class I Posts) Recruitment Rules 1963.

2. **Application**—These rules shall apply for recruitment to the posts specified in column 2 of the Schedule to these rules.

3. **Number of posts, classification and scale of pay.**—The number and classification of the posts and the scale of pay attached thereto shall be as specified in columns 3, 4 and 5 of the said Schedule

4. **Nature, method of recruitment, age limits and qualifications etc.**—The nature of the posts, age limits, qualifications, method of recruitment and other matters relating thereto shall be as specified in columns 6 to 14 of the aforesaid Schedule:

(1) Provided that the upper age limits specified in column 7 of the said Schedule may be relaxed in the case of candidates belonging to the Scheduled Castes or the Scheduled Tribes and other special categories of persons in accordance with the general instructions issued by the Central Government from time to time;

(2) Provided also that the posts required to be filled by promotion may be filled by the direct recruitment if no suitable candidate is available for appointment thereto by promotion.

5. **Disqualification.**—(a) No person who has more than one wife living or who having a spouse living, marries in any case in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for appointment to the service;

(b) No woman whose marriage is void by reasons of the husband having a wife living at the time of such marriage or who has married a person who had a wife living at the time of such marriage, shall be eligible for appointment to service:

Provided that the Central Government may, if satisfied that there are special grounds for so ordering, exempt any person from the operation of this rule.

(c) No candidate who is called for the interview for appointment against direct recruitment quota under age concession admissible to Government servants, will be eligible for appointment, if after submitting the application he resigns from service either before or after the interview.
