## ADDITIONAL CONDITIONS OF WORK

#### (i) MAINTENANCE STAFF :

- 1. The scope of work in this maintenance contract providing required labour and service for the operation and maintenance of Electrical Installation as described in the schedule of work.
- 2. The staff will be deployed in one shift however the staff duty timings will be decided by controlling authority keeping in view the site requirements and situation arising at work.
- 3. The Wireman and Pump Operator should have valid wireman license.
- 4. One day weekly off (Preferably Sunday\_ can be availed by the worker, but he has to attend Sunday also if required and in emergency as per the instructions of field staff for which nothing extra will be paid, however he is entitled to avail compensatory off for the same. The contractor has to arrange duty in such a manner that the work on Sunday and holidays continue un-interrupted.
- 5. Age of staff person should not be less than 18 years.
- 6. The contractor shall have to arrange at his own cost all liveries, soap, duster clothes, cleaning agents as may be required.
- 7. The department does not guarantee absorption of staff employed by the contractor on the works.
- 8. Security clearance and entry passes to workers shall be arranged by the department free of cost as per the security norms set out by station.
- 9. Contractor has to make his own arrangements for payment of compensation / retirement benefits for the staff employed by him on the work. The department shall not be liable for any of the above contingencies.
- 10. Alternative arrangement shall have to be made by the contractor during leave period of the particular person so that the continuity of service is maintained during such leave periods.
- 11. An attendance register showing only the designation of the staff employed by the contractor shall be maintained by the contractor and fortnightly labour report will be submitted to department.
- 12. A complaint register shall be maintained and the complaints written thereon should be attended immediately.
- 13. The Service Tax, EPF charges, Cess, Labour Welfare charges if any paid will be reimbursed on production of original receipts alongwith the final bill.
- 14. All safety precautions as laid down in the respective ISS / IE Act / CPWD specifications and all other standards and specifications shall be observed by the workers employed by the contractor.
- 15. The contractor shall equip all his workers with necessary safety guards required for the work at his own cost. The department shall not be liable for payment of any compensation in whatever form for accidents of damages which may occur to any of the workers or to a third party during the course of execution of any works under the terms and conditions of this contract.
- 16. The contractor is bound to follow all the labour regulation / rules as set out by concerned labour authority of the region.
- 17. The person engaged mainly operate the pump as per requirement of Station, however other electrical works to keep the service intact will also be look after by the engaged person if required in emergency.
