Nature of Duties:- You will be required to work in the areas of Management Accounting, Cost Accounting, Financial Accounting, Financial Management, Direct Taxation and Indirect Taxation of Prasar Bharati or as decided by the Competent Authority from time to time.

In case, it has come to the notice of Prasar Bharati that the cost trainee has entered into contract of employment/ training with any other organisation/ employer before the expiry or termination of his contract with Prasar Bharati then his contract of training will be terminated by the Prasar Bharati immediately under intimation to the Institute.
- d. The training period of Cost Trainees at Prasar Bharati would be extended for subsequent year based on yearly appraisals.
- e. Prasar Bharati reserves the right to conduct test and/ or interview of the shortlisted candidates. No TA/DA etc. will be paid for attending the test/ interview.


