**INFORMATION AND INSTRUCTIONS FOR CONTRACTORS FOR e-TENDERING**

1. The intending bidder must read the terms and condition of CPWD 6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and instructions for bidders posted on web site shall form part of bid document.
3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website [www.tenderwizard.com/AIR](http://www.tenderwizard.com/AIR) free of cost.
4. But the bid can only be submitted after depositing processing fee in favour of ITI Limited and uploading the mandatory scanned document such as Demand draft or Pay order or Banker's cheque or Deposit or Call receipt or Fixed deposit receipts and Bank guarantee of any schedule bank towards EMD in favour of The Executive Engineer (Elect.) Civil Construction Wing, All India Radio, Bengaluru-560001 and other documents as specified.
5. Those contractors not registered on the website mentioned above, are required to get registered beforehand. if needed they can be imparted training on online bidding process as per details available on the Website
6. The intending bidder must have valid class-III digital signature to submit the bid.
7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.

8. Contractor can up load documents in the form of JPG format and PDF format.
9. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in yellow colour and the moment rate is entered, it turns sky blue.  
In addition to this, while selecting any of the cells a warning appears that if a any cell is left blank the same shall be treated as "0".  
Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO)
10. SC / ST contractors enlisted under class -V are exempted from processing fee payable to ITI limited.
11. All tendered rates shall be inclusive of GST and any other tax, levy or cess applicable on last stipulated date of receipt of tender.
12. TDS on GST shall be deducted from the bill at applicable rates.

List of Documents to be scanned and uploaded within the period of bid submission:

Treasury Challan / Demand Draft/Pay order or Banker's Cheque /Deposit at Call Receipt/ FDR / Bank Guarantee of any Scheduled Bank against EMD (N.A) and affidavit as additional document on non-judicial stamp paper of Rs.100-00 duly notarized **in Original** and Name of work to be mentioned above the content of the affidavit. Affidavit should be procured and notarized after the date of floating of the tender.
2. Demand Draft / Pay order or Banker's Cheque of any scheduled Bank / Proof of online payment through Credit card/Debit card/e-Banking towards cost of Processing fee.
3. Enlistment Order of the contractor and Electrical Inspectorate certificate.
4. Certificates of work experience.
5. Affidavit as per clause 1.2.3 of CPWD dully notarized in **Original** and Name of work to be mentioned above the content of the affidavit.
6. GST Registration certificate of the State in which the work is to be taken up, if already obtained by the bidder along with upto date GST return in Annexure-3B
7. Partnership deed (if required)
8. Under taking form duly filled and signed by the agency as per page 1 & 2 of CPWD 8.

If the bidder has not obtained GST registration in the State in which the work is to be taken up, or as required by GST authorities then in such a case the bidder shall scan and upload following under taking along with other bid documents.

" If work is awarded to me, I/we shall obtain GST registration certificate of the State, in which work is to be taken up, within one month from the date of receipt of award letter or before release of any payment by CCW, whichever is earlier, failing which I/we shall be responsible for any delay in payments which will be due towards me/us on a/c of the work executed and/or for any action taken by CCW or GST department in this regard.
