- 1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all documents required.
- 2. Information and instructions for bidders posted on website shall form part of bid document.
- 3. The bid document consisting of plans, specifications, schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from the website <u>www.tenderwizard.com/AIR</u> free of cost.
- 4. But the bid can only be submitted after depositing Processing Fee in favor of M/s. ITI Limited and deposition of original EMD in the office of Assistant Engineer (E) CCW, AIR, PB(IPSB), Pune-16 or subdivision / division office of any Assistant Engineer (C/E) / Executive Engineer (C/E), Civil Construction Wing, All India Radio, within the period of bid submission (The EMD document shall only be issued from the place in which the office of receiving sub-division / division office is situated) and uploading the mandatory scanned documents such as Insurance Surety Bonds, Account Payee Demand Draft or Banker's Cheque or Fixed Deposit Receipt from any of the Commercial Bank towards EMD in favor of <u>Executive Engineer (E), CCW AIR PB (BCI), Mumbai-20</u>, receipt for deposition of original EMD from the Assistant Engineer (E), CCW, AIR, PB(IPSB), Pune-16 or sub-division / division office of any Assistant Engineer (C/E) / Executive Engineer (C/E), Civil Construction Wing, All India Radio, within the period of bid submission and other documents as specified.
- 5. Detailed procedure can be seen in the CPWD-6 for e-Tendering
- 6. Contractors, who are not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the said website
- 7. The intending bidder must have valid **Class-III** Digital Signature to submit the bid.
- 8. On the date of opening of the Bid, the bidder can login and see the bid opening process. After opening of Bids he will receive the competitor bid sheets.
- 9. Bidder can upload documents in the JPG or PDF format.
- 10. Bidder must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink color and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells in the SOQ a warning appears that if any cell is left blank the same shall be treated as "0" (zero).

Therefore, if any cell in the SOQ is left blank and no rate is quoted by the bidder, rate for such item shall be treated as "0" (zero).

Rates for minus items, if quoted above reserve price shall be considered otherwise shall be treated at par with reserve price.

11. SC/ST bidders enlisted under Class-V category are exempted from processing fee of e-Tender payable to M/s. ITI Ltd.
