4. (i) The original EMD is to be deposited either in the Division office of Executive Engineer (Civil), CCW, AIR, MHPD, New Delhi or concerned sub division within the period of Bid submission and uploading the mandatory scanned documents such as Demand draft or Pay order or Banker's Cheque or Deposit at call receipt or Fixed Deposit receipt and Bank Guarantee of any Scheduled bank towards EMD in favour of ("PB,BCI, EE-(C)-MHPD, CCW,AIR, New Delhi").

ii) Detailed procedure can be seen in the CPWD -6 for e-tendering.

- 5. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
- On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.

Contractor can upload documents in the form of JPG/PDF format in ZIP file.

- Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue.
  - In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0".
  - Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
- 9. The contractor shall quote rates including work contract tax, GST, other taxes, Cess and levies, nothing extra shall be paid over quoted rates. However, Contractor shall submit to the department the GST compliant tax invoice along with running /final account bills. -As per NIT-

- Affidavit as per Clause 1.2.1 (b) of CPWD-6 on non-judicial stamp paper of Rs. 100/- duly Notarized.
- Affidavit as per Clause 9 of form CPWD-6 on non judicial stamp aper of Rs. 100/- duly Notarized. (Notarization shall be done after the date of uploading/publishing of NIT. Name of the work and NIT No, shall be mentioned on front page of affidavit).
- Partnership deed (if any) and power of attorney (if any) in the name of authorized partner/ representative.
- 7. Copy of Bidder PAN card.
- 8. Latest GST return filed for last month / quarter.
- 9. Certificate of registration for Goods and Services Tax. (As per NIT)

(It is mandatory to upload scanned copies of all the documents, if one of these documents is not uploaded, then bid will become invalid and shall summarily be rejected).

The bidder shall be required to produce original documents for verification on demand by Assistant Engineer (Civil).
