The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/AIR free of cost.
- 4. (i) The bidder should scan and upload the documents for financial instruments, such as Demand Draft or Pay order or Banker's Cheque or Deposit at call receipts of any schedule bank towards EMD in favour of 'PB, BCI, Executive Engineer(C) MHPD, CCW, AIR, New Delhi and e-tender processing fee as admissible shall be payable to M/s ITI Limited through their e-gateway by Credit Card/Debit Card, Internet Banking or RTGS/NEFT facility.

- 9. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0".
