G.S.R. 581.—In exercise of the powers conferred by the proviso to article 309 of the constitution of India, the President hereby makes the following rules to regulate the method of recruitment to Group 'C' Programme (Technical) posts in various units of Doordarshan under the Ministry of Information and Broadcasting, namely :—

1. Short title and commencement.—(1) These rules may be called the Doordarshan Programme (Technical) Group 'C' posts Recruitment Rules, 1988.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Application.—These rules shall apply to the posts specified in column 2 of the schedule annexed to these rules.

3. Number of posts, their classification and scale of pay.—The number of the said posts, their classification and the scales of pay attached thereto shall be as specified in columns 3 to 5 of the said schedule.

4. Method of Recruitment, age limit, qualifications.—The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns 6 to 15 of the aforesaid schedule.

5. If a person appointed to any post covered in these rules is considered for promotion to higher post, all persons senior to him in his grade will also be considered notwithstanding that they may not have rendered the requisite number of years of service :

Provided that the seniors, who are considered for promotions under this rule should have completed the period of probations if any:

6. Disqualification.—No person—

- (i) who has entered into or contracted a marriage with a person having a spouse living, or
- (ii) who having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts :

Provided that the Central Government may, if satisfied, that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any

person from the operation of this rule.

7. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

8. Savings.—Nothing in these rules shall affect reservation relaxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
