- 2. Information and instructions for bidders posted on website shall form part of bid document.
- 3. The bid document consisting of plans, specifications, schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from the website https://air.ewizard.in/ free of cost.
- 4. But the bid can only be submitted after depositing Processing Fee in favour of M/s. - 1. The Executive Engineer of all divisions of CCW AIR should receive the original EMD for tender of other division.
- 2. The NIT approving authority/EE at the time of issue of NIT shall also fill and upload the following prescribed format of receipt of deposition of original EMD along with NIT: -
- 3. The Executive Engineer receiving EMD in original form shall examine the EMD deposited by the bidder and shall issue a receipt of deposition of earnest money to the agency in a given format upload by tender inviting EE. The Receipt may be issued by the AE (P)/AE/AAO.

1. The Executive Engineer (E), Civil Construction Wing, All India Radio, Mumbai-20, on behalf of President of India invites e-tender from approved and eligible contractors of CPWD and those of appropriate list of BSNL. MES, Railways, Department of Post and Gujarat State PWD for the work: Special Repairs to AIR Ahmedabad. (Sh- Replacements of existing Non-Essential, Essential and APFCR LT panels with Required cables and earth electrodes)

The enlistment of the contractors should be valid on the last date of sale of tenders.

- The work is estimated to cost ₹. 6,13,673/- This estimate, however, is given merely as a rough guide.
- 1.1.1. The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NITs for calling the bids. He will also nominate Division which will deal with all matters relating to the invitation of bids. For composite bid, besides indicating the combined estimated cost put to bid, should clearly indicate the estimated cost of each component separately. The eligibility of bidders will correspond to the combined estimated cost of different components put to bid
- 1.2. Intending bidder is eligible to submit the bid provided he has definite proof from the appropriate authority i.e. not below the rank of Executive Engineer, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works, in the last seven years ending in Central Government, State Government, PSUs and other Government Local bodies. The works completed up to previous day of last date of submission of tender shall also be considered.

Criteria of eligibility for submission of bid documents

1.2.1. Conditions for Non-CPWD registered contractors only, if bids are also open to non-CPWD Contractors

This work can be part of eligible work at 1.2.1 (i) above or as a separate work

(i) Three similar works each of value not less than Rs.................. Or two similar works each of value not less than Rs......(all figures rounded to nearest

convenient figure) during the last 7 years ending last day of the month previous to the one in which tenders are invited.

(ii) For EPC tender under Mode- I/II only (Applicable for CPWD enlisted contractors of appropriate class also).

One completed work costing not less than Rs. _____ executed with the structural system technology as proposed by bidder in the letter of transmittal during the last 7 years ending last day of the month previous to the one in which tenders are invited. This work can be part of eligible work at 1.2.1 (i) above or as a separate work

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid. This is applicable for 1.2.1 as well as 1.2.2 (Para 1.2.1(i) and Para 1.2.2(i) are not applicable for CPWD enlisted contractors of appropriate class. Para 1.2.1(ii) and Para 1.2.2(ii) are also applicable for CPWD enlisted contractors of appropriate class).

To become eligible for issue of bid, the bidders shall have to furnish an <u>undertaking</u> as under (<u>Applicable if</u> <u>work experience is stipulated in para 1.2 above</u>):

"I/We undertake and confirm that eligible similar work/s has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in CCW-AIR in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee." (Scanned copy is to be uploaded at the time of submission of bid).

- 1.2.3. When bids are invited from non CPWD contractors and CPWD class II contractors as per provisions of clause 1.2.1 above, it will be mandatory for non CPWD contractors and CPWD class-II contractors to upload the work experience certificate(s) and the affidavit as per the provisions of clause 1.2.2. But for such bids, Class-I contractors of CPWD are eligible to submit the bids without submission of work experience certificate and affidavit. Therefore, CPWD class-I contractors shall upload two separate letters for experience certificate and affidavit that these documents are not required to be submitted by them. Uploading of these two letters is mandatory otherwise system will not clear mandatory fields
 - 2. Agreement shall be drawn with the successful tenderer on prescribed Form No. 7, which is available as a Govt. of India Publication. Tenderer shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
 - 3. The time allowed for carrying out the work will be <u>2 (Two) Months</u> from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
 - 4. The site for the work is available.
 - 5. Tender documents consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be seen from website https://air.ewizard.in/ free of cost.
 - 6. Pre Bid conference shall be held in the chamber of O/o EE (E), CCW, AIR, Mumbai on _____ at Mumbai ____ am to clear the doubt of intending bidders if any.  - 7. After submission of the Tender the contractor can re-submit revised tender any number of times but before last time and date of submission of tender as notified.
 - While submitting the revised tender, contractor can revise the rate of one or more item/s any number
 of times (he need not re-enter rate of all items) but before last time and date of submission of tender as
 notified.

- 9. When tenders are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the tender submitted earlier shall become invalid.
- 10. Earnest Money of ₹ 12,273=00 the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee (for balance amount as prescribed) from any of the Commercial Banks [drawn in favour of The Executive Engineer (E), CCW AIR PB (BCI), Mumbai-20] shall be scanned and uploaded to the e-tendering website within the period of bid submission. The original EMD should be deposited either in the office of Executive Engineer (E), CCW, AIR, PB (IPSB), Mumbai-20 or division office of any Executive Engineer (C/E), Civil Construction Wing, All India Radio, within the period of bid submission (The EMD document shall only be issued from the place in which the office of receiving division office is situated). The Executive Engineer (C/E), CCW, AIR, PB (IPSB), shall issue a receipt of deposition of earnest money deposit to the bidder in a prescribed format uploaded by the Executive Engineer (E), CCW, AIR, PB (IPSB), Mumbai 20 in the NIT. This receipt shall be also uploaded to the e-tendering website by the intending bidder up to the specified bid submission date and time. A part of Earnest Money is acceptable in the form of Bank Guarantee also. In such case, 50% of Earnest Money or Rs.20 lakh, whichever is less, will have to be deposited in shape prescribed above, and balance in shape of Bank Guarantee of any Commercial Bank having validity for six months or more from the last date of receipt of bids which is to be scanned and uploaded by the intending bidders. The FDR shall be accepted only if it is valid for a period of six months or more after date of opening of the Tender.

The Certified copy of all the scanned and uploaded documents shall be deposited by the lowest tenderer within a week after opening of financial bid failing which the tender shall be rejected.

The certified copy of all the scanned and uploaded documents specified in the Press Tender Notice/NIT shall be deposited by me/us with the Executive/Executive Engineer (Electrical), Civil Construction Wing, All India Radio, Mumbai-20, in case I/we become the lowest tender within a week of opening of the financial bid otherwise the Department (CCW-AIR) may reject the tender and take action to debar me/us from tendering in CCW-AIR for a period of three years and can write to the Competent Authority for cancellation of my/our enlistment.

(Originals of the uploaded documents shall be shown for verification).

Interested contractor who wish to participate in the bid has also to make following payments within the period of bid submission:

E-Tender Processing Fee admissible shall be payable to M/s. ITI Limited through their e-gateway by credit/debit card, internet banking or RTGS/NEFT facility.

Copy of Enlistment Order and certificates of work experience and other documents as specified in the tender/press notice shall be scanned and uploaded to the e-Tendering website within the period of bid submission. However, certified copy of all the scanned and uploaded documents as specified in the tender notice shall have to be submitted by the lowest bidder only within a week physically in the office of tender opening authority.

Online bid documents submitted by intending bidders shall be opened only of those bidders, who have deposited e-Tender Processing Fee with M/s. ITI Limited and Original EMD deposited with division office of CCW, AIR, PB (IPSB) Mumbai-20 or division office of any Executive Engineer (C/E), Civil Construction Wing, All India Radio, within the period of bid submission and other documents scanned and uploaded are found in order.

The bid submitted shall be opened at 11:30 Hrs. on 01/02/2023

- 11. The bid submitted shall become invalid and e-Tender Processing Fee shall not be refunded, if:
 - (i) The bidder is found ineligible;

- (ii) The bidder does not upload all the documents (including GST) as stipulated in the bid document including the copy of receipt for deposition of Original EMD and affidavit about the certified copy of all the scanned and uploaded documents;
- (iii) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the lowest tenderer in the office of tendering opening authority;
- 12. The contractor whose tender is accepted will be required to furnish Performance Guarantee of 3% (Three percent) of the tendered amount within the period specified in Schedule F. This guarantee shall be in the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed Deposit Receipt or Bank Guarantee from any of the Commercial Banks in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F', including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor.
- 13. Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may requisite and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.
- 14. The competent authority on behalf of President of India does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without the assignment of a reason. All tenders, in which any of the prescribed conditions is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer, shall be summarily rejected.
- 15. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 16. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 17. The contractor shall not be permitted to tender for works in the CCW AIR PB(BCI) Circle (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the Civil Construction Wing of All India Radio or in the Ministry of Information & Broadcasting. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
- 18. No Engineer of Gazette rank or other Gazette officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of two years after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractor's service.

- 19. The tender for the works shall remain open for acceptance for a period of 30 (Thirty) days from the date of opening of Price Bid. If any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the Department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.

President of India represented through Executive Engineer (E) CCW AIR Mumbai, (Hereinafter referred as the (Address of Sub Division) 'Principal/Owner', which expression shall unless repugnant to the meaning or context hereof include its successors and permitted assigns)

AND

Preamble

WHEREAS the Principal / Owner have floated the Tender (NIT No. 040/EDM/MUM/2022-23) (hereinafter referred to as "Tender/Bid") and intends to award, under laid down organizational procedure, contract for Special Repairs to AIR Ahmedabad. (Sh- Replacements of existing Non-Essential, Essential and APFCR LT panels with required cables and earth electrodes)

Hereinafter referred to as the "Contract". AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s).

AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "Integrity Pact" or "Pact"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

Article 1: Commitment of the Principal/Owner

- 1. The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
 - a) No employee of the Principal/Owner, personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
 - b) The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Principal/Owner will, in particular, before and during the Tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the Tender process or the Contract execution.
- 2. The Principal/Owner shall endeavor to exclude from the Tender process any person, whose conduct in the past has been of biased nature.
- 3. If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures

Article 2: Commitment of the Bidder(s)/Contractor(s)

- 1. It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of fraud or corruption or Coercion or Collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2. The Bidder(s)/Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:
 - a) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal/Owner's employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the Tender process or during the execution of the Contract.
 - b) The Bidder(s)/Contractor(s) will not enter with other Bidder(s) into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process
 - c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/ Contract(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically
 - d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the names and addresses of agents/ representatives in India, if any. Similarly Bidder(s)/Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item
 - e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
- 3. The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences
- 4. The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practice means a willful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.
- 5. The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/ her reputation or property to influence their participation in the tendering process).

Article 3: Consequences of Breach

Without prejudice to any rights that may be available to the Principal/Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder/ Contractor accepts and undertakes to respect and uphold the Principal/Owner's absolute right:

- 1. If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days' notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. Such exclusion may be forever or for a limited period as decided by the Principal/Owner.
- 2. Forfeiture of EMD/Performance Guarantee/Security Deposit: If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or

terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Contractor.

3. Criminal Liability: If the Principal/Owner obtains knowledge of conduct of a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of IPC Act, or if the Principal/Owner has substantive suspicion in this regard, the Principal/Owner will inform the same to law enforcing agencies for further investigation.

Article 4: Previous Transgression

- The Bidder declares that no previous transgressions occurred in the last 5 years with any other Company in any country confirming to the anticorruption approach or with Central Government or State Government or any other Central/State Public Sector Enterprises in India that could justify his exclusion from the Tender process.
- 2. If the Bidder makes incorrect statement on this subject, he can be disqualified from the Tender process or action can be taken for banning of business dealings/ holiday listing of the Bidder/Contractor as deemed fit by the Principal/ Owner.
- 3. If the Bidder/Contractor can prove that he has resorted / recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal/Owner may, at its own discretion, revoke the exclusion prematurely.

Article 5: Equal Treatment of all Bidders/Contractors/Subcontractors

- 1. The Bidder(s)/Contractor(s) undertake(s) to demand from all subcontractors a commitment in conformity with this Integrity Pact. The Bidder/Contractor shall be responsible for any violation(s) of the principles laid down in this agreement/Pact by any of its Subcontractors/sub-vendors
- 2. The Principal/Owner will enter into Pacts on identical terms as this one with all Bidders and Contractors
- 3. The Principal/Owner will disqualify Bidders, who do not submit, the duly signed Pact between the Principal/ Owner and the bidder, along with the Tender or violate its provisions at any stage of the Tender process, from the Tender process

Article 6- Duration of the Pact

This Pact begins when both the parties have legally signed it. It expires for the Contractor/Vendor 12 months after the completion of work under the contract or till the continuation of defect liability period, whichever is more and for all other bidders, till the Contract has been awarded. If any claim is made/lodged during the time, the same shall be binding and continue to be valid despite the lapse of this Pacts as specified above, unless it is discharged/determined by the Competent Authority, CCW AIR.

Article 7- Other Provisions

- 1. This Pact is subject to Indian Law, place of performance and jurisdiction is the Headquarters of the Division of the Principal/Owner, who has floated the Tender.
- 2. Changes and supplements need to be made in writing. Side agreements have not been made.
- 3. If the Contractor is a partnership or a consortium, this Pact must be signed by all the partners or by one or more partner holding power of attorney signed by all partners and consortium members. In case of a Company, the Pact must be signed by a representative duly authorized by board resolution.
- 4. Should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intensions.
- 5. It is agreed term and condition that any dispute or difference arising between the parties with regard to the terms of this Integrity Agreement / Pact, any action taken by the Owner/Principal in accordance with this Integrity Agreement/ Pact or interpretation thereof shall not be subject to arbitration.

Article 8- LEGAL AND PRIOR RIGHTS

All rights and remedies of the parties hereto shall be in addition to all the other legal rights and remedies belonging to such parties under the Contract and/or law and the same shall be deemed to be cumulative and not alternative to such legal rights and remedies aforesaid. For the sake of brevity, both the Parties agree that this Integrity Pact will have precedence over the Tender/Contact documents with regard any of the provisions covered under this Integrity Pact.

IN WITNESS WHEREOF the parties have signed and executed this Integrity Pact at the place and date first above mentioned in the presence of following witnesses:

TERMINATION OF CONTRACT ON DEATH

Without prejudice to any of the rights or remedies under this contract if the contractor dies, the Divisional Officer on behalf of the President of India shall have the option of terminating the contract without compensation to the contractor.

Whenever any claim, against the contractor from the payment of sum money arises out or under the contractor, Government shall be entitled to recover such by appropriating. In part or whole, the security deposit of the contractor and he shall any Government promise notes, etc. forming the whole or part of such security. In the event of the security being insufficient or if no sum recoverable as the case may be shall be deducted from any sum then due which at any time. where after may become due from the contractor under this or any other contract with Government should this sum be not sufficient to cover the full amount recoverable the contractor shall be to Government on demand the balance remaining due.

Government shall have the right to cause any audit and technical examination of the works and the bill of the contractor including all supporting vouchers, abstracts etc. to be made after payment of the final bill and if as a result of such audit and technical examination any sum is found to have been overpaid in respect of any work done by him under contract and found not to have been executed the contractor shall be liable to refund the amount cover the same from him the manner prescribed in sub-clause(1) of this clause or in any other manner legally permissible and if as result of audit and technical examination it is found that the contractor was paid less than that was due to him under if the amount of such under payment shall be fully paid by the Government to the contractor.

- 1. The work is to be executed at All India Radio, Navranapura, Ahmedabad
- 2. The work shall be executed as per CPWD General Specifications for Electrical Works Part I, II and as amended up to date, relevant I.E. Rules, BIS, IEC and as per directions of Engineer in –Charge. These additional Specifications are to be read in conjunction with above and in case of variations; specifications give in this Additional condition shall apply. However, nothing extra shall be paid on account of these additional specifications & conditions as the same to be read along with schedule of quantities for the work.
- 3. The tenderers should, in their own interest, visit the site and familiarizes themselves with the site conditions before tendering.
- 4. No T & P shall be issued by the Department and nothing extra shall be paid on account of this.
- 5. The tenders are advised not to deviate from the technical specifications / items, commercial terms and conditions of NIT like terms of payment, guarantee, arbitration clause, escalation etc.
- 6. The price bids of only prequalified firm shall be opened. The time and date of opening of price bid shall be intimately later on.
- 7. In case it is found that the tender of any of tenderer is not in line with NIT Specification, requirements or contains many deviations, the department reserves the right to reject the tender of such firm(s) without making any reference to the tenderers(s).
- 8. The tenders will be opened by the Executive Engineer (E), Civil Construction Wing, All India Radio, Mumbai in the presence of the interested representatives of the tenderers who wish to be present on due date as decided.
- 9. The department reserves the right to reject any or all the tenders and call for fresh tenders as the case may be without assigning any reason.

10. Terms of Payment:-

- i) **80%** of the Contract value against delivery, pro-rata of the value of goods delivered after checking of the same at the site of the work by the Engineer-in-Charge and certified all these (materials and goods) in good condition without any defect and worth use in work.
- ii) **10%** on completion of installation work duly certified by the Engineer-in-Charge (done without defect &as per specification).
- iii) 10% will be paid after testing, commissioning and handing over to the department for beneficial use.
- iv) A sum @ 2.5% of the gross amount of the bill shall be deducted from each running bill as well as final bill of the contractor. Such deductions shall be made unless the contractor has deposited the amount of security at the rate mentioned in cash or Government securities or Fixed Deposit Receipts. This is in addition to the performance guarantee that the contractor is required to deposit.

11. Rates:-

The rates quoted by the tenderer, shall be firm and inclusive of all taxes (including GST), duties and levies and all charges for packing, forwarding, insurance, freight & delivery, installation, testing, commissioning etc. at site including temporary constructional storage, risk, overhead charges, general liabilities / obligations and clearance from local authorities, if any. However, the fee for these inspections shall be borne by the department. The department will not issue Octroi exemption certificate.

12. Completeness of tender:-

All sundry equipment, fittings, unit assemblies, accessories, hardware items, foundation bolts, termination lugs for electrical connections and all other items which are useful & necessary for efficient assembly and installation of equipment & components of the work shall be deemed to have been included in the tender irrespectively of the fact whether such items are specifically mentioned in the tender documents or not.

13. Care of the building:-

Care shall be taken by the contractor while handling and installing the various equipment's and components of the work to avoid damage to the building. He shall be responsible for repairing all damages and restoring the same to their original finish at his cost. He shall also remove at his cost all unwanted and waste materials arising out of the installation from the site of work.

14. Completion Period:-

The completion period of **2 (Two) Months** indicated in the tender documents is for the entire work of planning, designing, supplying, and installation, testing, commissioning and handing over the entire system to the satisfaction of the Engineer-in-charge.

15. Performance Guarantee:-

The successful tenderer shall submit an irrevocable performance guarantee of 5% of the tendered amount in addition to the other deposits mentioned elsewhere in the contract for his proper performance of the contract agreement within 15 days of issue of letter of intent. This guarantee shall be in the form of government securities or fixed deposit receipts or guarantee bonds of any scheduled bank or the State Bank of India in the specified format. The performance guarantee shall be initially valid up to the stipulated date of completion plus 60 (sixty) beyond. This bank guarantee shall be kept valid till the recording of completion certificate for the work by the competent authority.

16. Guarantee:-

All the equipment's shall be guaranteed for a period of 12 (twelve) months from the date of taking over the installation by the department against unsatisfactory performance and / or breakdown due to defective design, workmanship of materials. The equipment's or components or any past thereof, so found defective during guarantee period shall be forthwith repaired or replaced with cost, to the satisfaction of the Engineer-in-Charge. In case it is felt by the department that undue delay is being caused by the contractor in doing this, the same will be got done by the department at the risk and cost of the contractor. The decision of the Engineer-in-charge in this regard shall be final.

17. Power Supply:-

Electric service connection of 415 V.3 phase, 4 Wire, 50 Hz, AC supply shall be provided by the department for installation purpose free of charge.

18. Water supply:-

Water supply shall be made available by the department at one point in the campus free of cost.

19. Data Manual and Drawings to be furnished by the tenderers.

With tender:- The tenderer shall furnish along with the tender, detailed technical literature, pamphlets and performance data for appraisal and evaluation of the offer.

20. After award of work:-

The successful tenderer should furnish well in advance three copies of detailed instructions and manuals of manufacturer for all items of equipment's regarding installation and maintenance including preventive maintenance and troubleshooting together with all the relevant date sheet, spare part catalogue and workshop procedure for repairs, assembly and adjustment etc. all in triplicate.

Extent of work

- i. The work shall comprise of entire labour including supervision and all material necessary to make a complete installation and such tests and adjustments and commissioning as may be required by the department. The term complete not only mean major items of the plant and equipment's covered by specifications but all incidental sundry components necessary for complete execution and satisfactory performance of installation with all layout charts whether or not those have been mentioned in details in the tender documents in connection with this contract.
- ii. Minor building works, necessary for installation of equipment's, foundation, making opening in walls or in floors and restoring to their original condition, finish and necessary grouting etc. as required.
- iii. The work is turnkey project. Any item required for completion of the project but left inadvertently shall be executed within the quoted rates.

21. Inspection and testing:

Copies of all documents of routine and type test certificate of the equipment's, carried out at the manufacturer's premises, shall be furnished to the Engineer-in-Charge and consignee. After completion of the work in all respect, the contractor shall offer the installation for testing and operation.

22. Validity:-

Tender shall be valid for acceptance for a period of 30 (Thirty) days from the date of opening of Price Rid

- 23. Compliance with Regulations & Indian Standards: All work shall be carried out in accordance with relevant regulation, both statutory and those specified by Indian Standards related to the works covered by this specification. In particular the equipment and installation will comply with the following.
 - i. Factories Act with update amendments.
 - ii. Indian Electricity Rules with update amendments.
 - iii. IS & BS Standards as applicable with update amendments.
 - iv. Workmen's compensation Act with update amendments.
 - v. Statutory norms prescribed by any local bodies like power Supply Company etc.

- 24. Nothing in the specification shall be construed to relieve the successful tenderer of his responsibilities for design manufacture and installation of the equipment with all accessories in accordance with currently applicable statutory regulation and safety codes.
- 25. Successful tenderer shall arrange for compliance with statutory provisions for safely regulation and departmental requirements of safety codes in respect of labour employed on the work by the tenderer. Failure to provide such safety requirements would make the tenderer liable for penalty of Rs. 500.00 for each default. In addition, the department will be at liberty to make arrangement for the safety requirements at the cost of tenderer and recover the cost thereof from him.

26. Indemnity:-

The successful tenderer shall at all times indemnify the department consequent on this works contract. The successful tenderer shall be liable in accordance with the Indian Law and Regulation for any accident occurring due to any cause and the department shall not be responsible for any accident or damage incurred or claims arising there from during the period of erecting, construction and putting into operation the equipment and ancillary equipment's under the supervision of the successful tenderer in so far as the latter is responsible. The successful tenderer shall also provide all insurance including third party insurance as may be necessary to cover the risk. No extra payment would be made to the successful tenderer due to the above.

27. Erection Tools:-

No tools and tackles either for unloading or for shifting the equipment's for erection purpose would be made available by the department. The successful tenderer shall make his own arrangements for all these facilities.

28. Cooperation with other agencies:-

The successful tenderer shall coordinate with other contractors and agencies engaged in the construction of the building, if any, and exchange freely all technical information so as to make the execution of this works contract smooth. No remuneration should be claimed from the department for such technical cooperation. If any unreasonably hindrance is caused to other agencies and any completed portion of the work has to be dismantled and redone for want of cooperation and coordination by the successful tenderer during the course of work, such expenditure incurred will be recovered from the successful tenderer if the restoration work to the original condition or specification of the dismantled portion of the work was not undertaken by the successful tenderer himself. The work will be carried out with least disturbance during shifting and shut down taken in consultation with client department.

29. Mobilization Advance:-

No mobilization advance for this work shall be paid.

30. Insurance and storage:-

All consignments are to be duly insured up to the destination from warehouse at the cost of the supplier. The insurance cover shall be valid till the equipment is handed over duly installed, tested and commissioned.

31. Verification of correctness of Equipment at destination:-

The contractor shall have to produce all the relevant records to certify that the genuine equipment from the manufacturers has been supplied and erected.

32. Painting:-

This shall include cost of painting of entire installation before dispatch to the site. However, angle iron post, steel fabric, supports etc. shall be painted with required shade including painting with the costs of anticorrosive primer paint at site.

33. Maintenance:-

Sufficient trained and experienced staff shall be made available to meet any exigency of work during the guarantee period of one year from the handing over of the installation.

34. Interpreting Specifications:-

In interpreting the specifications, the following order of decreasing importance shall be followed in case of contradictions.

- i. Description of Schedule of quantities.
- ii. Particular specification and special condition.
- iii. Drawings.
- iv. CPWD Specifications.
- v. Relevant BIS or other international code in case BIS Code is not available/ ASHRAE standards.

Special Condition for Internal Electrical Installation works

- 1) All material required to be used on work shall be got approved from the Engineer-In-Charge, we in advance.
- 2) Earthing, Cable laying, Cement concrete works and testing of the installation shall be done in presence of the Engineer-In-Charge or his authorized representative.
- 3) On completion of work the Contractor shall test the installation and produce Test Certificate along with completion plan in accordance with the CPWD specification failing which a recovery shall be made from the bill of the Contractor as per Clause 8B.
- 4) Description of items underlined in the Schedule of work shall be used for abbreviation nomenclature of items for measurement and running account bills only.
- 5) All debris at site shall have to be removed by the contractor before handing over the installation to the Department.
- 6) The Main board shall be fabricated in consultation with the Engineer-In-Charge. Adequate space for providing energy meter, Cut out for providing Energy Meter, Cut out for providing Service Connection shall also be made on the Main Board.
- 7) The Successful tendered shall be making his own arrangement for storage and watch and ward of materials whether the same brought by him or supplied by the department. He shall remain responsible for watch and ward of installation and other fitting till these are commissioned and handed over to the department.
- 8) Cement required for the work shall have to be procured by the Contractor himself.
- 9) Electrical contractor will make recess in-brick work by cutting chases for provision of Electrical conduit and metal box according to the electric drawings for electrical services. Electrical Contractor will fix the conduits and boxes and there after close the chases up to the surface of masonry work in cement mortar 1:4 (1 Cement 4 Sand). There after surface of chases shall be plastered and finished by the Contractor (Civil Contractor) with mix and specification same as for plaster to ensure smooth and even surface. Nothing extra shall be paid to the contractor for above operations irrespective of whether the chases are not before or after plastering of the Wall.
- 10) All the fitting and fans should be proper Earthed.
- 11) Termination of wiring inside the DB's and Main Board should be by crimped connection. For which no extra payment shall be made.
