SCOPE OF WORK

- 1) BID FOR HIRING OF TAXIES FOR LOCAL AND OUTSTATION USE OF VEHICLES ON DEMAND FOR THE YEAR 2022-23:
 - a) SEDAN [This segment includes passenger cars with mid-size design in a three-box configuration and usually a length between 3600 to 4500 mm. approx.] (similar to Honda Amaze, Maruti Suzuki Dzire, Tata Tigor, Hyundai Xcent, Fort Aspire, Volkswagen Ameo, Tata Zest, Nissan Sunny, Toyota Etios)
 - b) PREMIUM SUV / MUV[This segment includes SUV / MUVs intended to provide passengers with increased comfort, a higher level of equipment and increased perception of quality than regular SUVs and length between 4300 to 4800 mm. approx.](similar to Toyota Innova Crysta, Fortuner, Ford Endeavour, Jeep Compass, Tata Hexa, Harrier, Honda CR-V)

INSTRUCTIONS FOR SUBMISSION OF BID

- 1. EVALUATION CRITERIA FOR L1: Refer to Annexure-II. Ranking Criteria for arriving at L-1 has been elaborated.
- 2. The rates shall be quoted in the prescribed proforma separately (ANNEXURE-II).
- 3. The firm should be located within Municipal Corporation Limits of Lucknow and should be in a position to provide vehicles at short notice for emergency use round the clock within 3 Hours.
- 4. The firm should be registered and should have a permanent office/ Branch office in Lucknow. The bidder must have registered at least 5 vehicles in respective RTO's under their name or in the name of the firm in any combination (Sedan, SUV/MUV, Premium SUV /MUV) and should be in a position to provide more vehicles at any given time only, should apply. All the vehicles should be January 2017 and later model. The successful bidder must produce all the original documents at the time of executing the agreement, failing which the successful bidder will not be considered even if it is the lowest bid.
- 5. REQUIREMENTS OF TECHNICAL QUOTATIONS (Details to be provided in **ANNEXURE –1**)
 - a. Name, address, telephone number of the firm.
 - b. Vehicles possessed, Model and vehicle registration number (3 Sedan & 2 SUV/MUV total 5 vehicles).
 - c. Photo copies of RC books of vehicles with fitness certificate of Yellow Board vehicle (all 5 vehicles).
 - d. Copies of the vehicle permit for the State and latest tax paid receipt (all 5 vehicles).
 - e. An undertaking that he will engage experienced drivers with minimum of 3 years professional / driving License and who can perform 24 hrs. duty. All drivers employed/contracted by the company should hold valid Driving License.
 - f. Any other relevant material other than the rates quoted.
 - g. Comprehensive insurance for all the vehicles provided is a must. Necessary documents need to be submitted/ uploaded.
 - h. The bidder should have experience in successfully executing similar contracts with PSUs / Government Departments / autonomous body / MNC / reputed organizations during the last 3 years (Supporting documents to be submitted compulsorily).
- 6. The technical Bids will be opened first and if the conditions of technical Bids are fulfilled, only then the Price Bid of the firm/agency adhering to the technical requirements, will be opened. Short listed (based on technical bid) bidder, who has quoted the lowest satisfactory rates (L1), and fulfills the other terms and conditions will be considered for the purpose of hiring of taxies.
- 7. The Head of Office, All India Radio, Lucknow reserves the right to reject any Bid. Further the "Right to specify/modify the requirements and type of vehicles to be hired rests with Head of Office, All India Radio, Lucknow".
- 8. Each bidder has to submit EMD (Earnest Money Deposit) of Rs. 10,000/- (Rupees Ten Thousand only) in the form of DD / Bankers Cheque payable in Favour of "DDO, All India Radio, Lucknow", payable at Lucknow along with bid documents. Unsuccessful bidder shall receive back the DD/ Bankers Cheque, soon after the completion of bid process. A scanned copy of the DD / Bankers Cheque to be uploaded in Annexure 1.
- 9. The successful bidder has to submit a performance guarantee either by way of Fixed Deposit Receipt or Bank Guarantee of. Rs. 2,00,000/- (Rupees Two Lakhs only) in the name of DDO, All India Radio, Lucknow, within three working days from the day of obtaining the contract.

- 10. The successful bidder has to execute an agreement with All India Radio, Lucknow and the said agreement shall be valid for one year at All India Radio, Lucknow during the year 2022-23 from the date of commencement of agreement. This can be extended for a period of one year if the services are found satisfactory.
- 11. The Bidder shall have a PAN / AADHAR Card issued by the respective Government agencies (self attested copies to be attached). The service provider should also have GST Registration Number issued by the concerned authorities (self attested copy to be attached).
- 12. The Bidder shall be bound by the rates quoted by him and agreed upon herein and shall not ask for any enhancement of the rates for the supply of vehicles during the period this agreement remains in force. If the supplier wish to discontinue the agreement in any eventuality, he shall apply for cancellation by giving 30 days notice to All India Radio, Lucknow so as to enable All India Radio to make alternative arrangements. In such event the agreement shall cease to have effect on the expiry of 30 days from the receipt of the notice. On termination of earlier agreement, if deemed suitable by HoO, All India Radio, Lucknow, the Firm categorized as L-2 may be offered the contract and L-1 would become ineligible for the next 1 year or as deemed fit by the HoO All India Radio, Lucknow.
- 13. The Odometer reading will start and terminate at All India Radio, Lucknow. The driver will not be allowed to take the vehicle for lunch or tea. Under no circumstances the odometer reading from vendor's office to All India Radio, Lucknow will be entertained.
- 14. The odometer of the taxi should be in working condition/order as per the regulation of RTO, Lucknow. If, however, it comes to our notice that meter readings are being tampered to show extra mileage than the actual distance, the department reserves the right to get the odometer of the vehicle inspected from any authorized workshop at the cost of the service provider and this may result in termination of the contract if found violated.
- 15. The vehicle should report for duty with sufficient fuel required to perform duty at All India Radio, Lucknow. The operator/owner should be aware of all rules and regulations of state/centre motor vehicle rules, traffic rules and other laws. The operator/owner shall ensure that the drivers are disciplined, well dressed, smart in turnout and behave properly with the officers and all staff of All India Radio, Lucknow.
- 16. In case of breakdown of hired vehicle while under use, the agency should make alternate arrangements immediately, failing which the additional amount spent for fulfilling the assignment by engaging other vehicle on the spot by the department, will be recovered from the travel agency.
- 17. All India Radio, Lucknow shall not be liable for any loss / damage/Death by accident / otherwise to the employees engaged by the agency. Any legal claim in the matter of wages, compensation, insurance, PF, Gratuity & other benefits in respect of the drivers engaged by the agency shall be the sole responsibility of the agency/firm.
- 18. If the services of the agency whose lowest tender has been accepted is not satisfactory, the Head of Office, All India Radio, Lucknow will have powers to terminate the contract of the agency and to accept next lowest tender for the remaining term, without inviting fresh quotations if deemed fit.
- 19. The vehicles are required to run outstation as per the requirement of the organization.
- 20. Night Charges Rates will be applicable to only those contracted taxis which will remain on duty from 2200 hrs to 0500 hrs i.e. Night Charges rates will be effective from 2200 hrs to 0500 hrs.

- 21. It will be the responsibility of the firm / agency to see that the driver should not, under any circumstances, drive the vehicle in a bad condition, under the influence of drugs or any kind of intoxication. The driver should have valid commercial license, valid vehicle documents, insurance etc. The driver should be courteous and punctual. The firm / agency will also be responsible for the conduct of the driver. If the vehicle is challenged for breaking the traffic rules by the driver and any penalty is imposed on the driver, the firm/agency will be responsible for the same.
- 22. On the events to be organized by All India Radio, Lucknow, the firm will have to provide vehicles to All India Radio, Lucknow as per requirement at the rates approved by All India Radio, Lucknow. The number of vehicles requisitioned on special events can exceed 05. If the required vehicle is not provided on time, and vehicle is hired from other travel agency and its payment is more than the approved rates, then the total difference will be recovered from the firm/agency.
- 23. If there is any delay in payment due to unavoidable circumstances, the travel agency should bear with it and not to cause any disruption in service.
- 24. The Last date of receipt of quotation via e-tender is 02.11.2022 by 14.00 Hrs.
- 25. The Technical quotations received via e-tender will be opened on 02.11.2022 at 15.00 Hrs.
- 26. The scope of work or stores to be tendered are available in the complete bid documents which can be viewed /downloaded from e-tender portal of https://prasarbharati.eproc.in. Both Technical Bid and Financial Bid will be submitted concurrently duly digitally signed in the website https://prasarbharati.eproc.in.
