1. Concern Head of Offices / ADG (E) Zone, has to ensure that officers should be relieved within ten days of issue of transfer order or the date mentioned against them.
2. Once the transfer representation against a particular order has been considered and a decision has been communicated, no further representation against the same order shall be considered by this Directorate at least up to 6 months from the date of the decision communicated.
3. Request for transfers received this Directorate is considered by the **Transfer Committee** in its meeting and order is issued in respect of those where it has been decided to accept the requests. Once a transfer order in a particular Cadre has been issued after receipt of the representations or requests of transfer in that Cadre and the name of a person does not figure in that order, it may be presumed that the request has been rejected by the transfer committee.
