

**INFORMATION AND INSTRUCTIONS FOR BIDDERS FOR e-TENDERING  
FORMING PART OF BID DOCUMENT AND TO BE POSTED ON WEBSITE**

The Executive Engineer (E), Civil Construction Wing, All India Radio, Mumbai-20 on behalf of President of India invites e-tender from **approved and eligible contractors from of CPWD and all eligible manufacturers and experienced specialized agencies dealing in solar water Heater System** in the appropriate class for the work:

- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all documents required.
- Information and instructions for bidders posted on website shall form part of bid document.
- The bid document consisting of plans, specifications, schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from the website [www.tenderwizard.com/AIR](http://www.tenderwizard.com/AIR) free of cost.
- But the bid can only be submitted after depositing Processing Fee in favour of M/s. ITI Limited and deposition of original EMD in the division office of Executive Engineer(E) CCW, AIR, PB(IPS), Mumbai-30 or division office of any Executive Engineer, Civil Construction Wing, All India Radio, within the period of bid submission (The EMD document shall only be issued from the place in which the office of receiving division office is situated) and uploading the mandatory scanned documents such as Demand Draft or Pay Order or Banker's Cheque or Deposit at Call Receipt or Fixed Deposit Receipt and Bank Guarantee of any Scheduled Bank towards EMD in favour of **Executive Engineer (E), CCW AIR PB(BCI), Mumbai-30**, receipt for deposition of original EMD to the Executive Engineer (E), CCW, AIR, PB(IPS), Mumbai-30 or division office of any Executive Engineer (E), Civil Construction Wing, All India Radio, within the period of bid submission and other documents as specified. The FDR shall be accepted only if it is valid for a period of six months or more after date of opening of the Tender.
- Detailed procedure can be seen in the CPWD-6 for e-Tendering
- Contractors, who are not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the said website
- The intending bidder must have valid **Class-III** Digital Signature to submit the bid.
- On the date of opening of the Bid, the bidder can login and see the bid opening process. After opening of Bids he will receive the competitor bid sheets.
- Bidder can upload documents in the JPG or PDF format.
- Bidder must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink color and the moment rate is entered, it turns sky blue.  
In addition to this, while selecting any of the cells in the SOQ a warning appears that if any cell is left blank the same shall be treated as "0" (zero).  
Therefore, if any cell in the SOQ is left blank and no rate is quoted by the bidder, rate for such item shall be treated as "0" (zero).  
**Rates for minus items, if quoted above reserve price shall be considered otherwise shall be treated at par with reserve price.**
- SC/ST bidders enlisted under Class-V category are exempted from processing fee of e-Tender payable to M/s. ITI Ltd.

12. Solar Water Heating System (SWH) systems, from Ministry of New and Renewable Energy (MNRE) approved manufacturers/channel partner of MNRE or their authorized representatives, fulfilling the eligibility criteria as per MNRE STD 01:2013 latest system specifications (up to date amended from time to time) and conforming to MNRE's guidelines/minimal technical requirements details enclosed /standards for SWH systems and amendments thereof. Tenderers who have obtained the valid test reports for SWH systems, issued by Solar Energy Centre /other Authorized Test Centers on the date of opening of technical bid and subsequently renewable up to period of validity of rates i.e., one year from the date of signing agreement, conforming to the above mentioned criteria would be eligible for participation. The Tenderers shall ensure full compliance with the below mentioned technical specifications for SWH systems, even in case of any further amendment(s) thereof in this regard, during the entire period of the Agreement signed under this Tender
