

**INFORMATION AND INSTRUCTIONS FOR BIDDERS FOR e-TENDERING
FORMING PART OF BID DOCUMENT AND TO BE POSTED ON WEBSITE**

The **Executive Engineer (E), Civil Construction Wing, All India Radio, Mumbai-20**, on behalf of President of India invites e-tender in two bid system [Step-I: Pre-qualification of specialized agencies as per eligibility criteria, & Step-II: Price bid] from approved and eligible contractors of CPWD and those of appropriate list of BSNL, MES, Railways, Department of Post and Gujarat State PWD and specialized agency relevant in the field of Air Conditioning for the work:

- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all documents required.
- Information and instructions for bidders posted on website shall form part of bid document.
- The bid document consisting of plans, specifications, schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from the website <https://prasarbharati.eproc.in/> free of cost.
- But the bid can only be submitted after depositing Processing Fee in favour of M/s. C1 India Pvt. Ltd and deposition of original EMD in the division office of Executive Engineer(E) CCW, AKASHVANI, PB(IPSB), Mumbai-20 or division office of any Executive Engineer (C/E), Civil Construction Wing, Akashvani, within the period of bid submission (The EMD document shall only be issued from the place in which the office of receiving division office is situated) and uploading the mandatory scanned documents such as Insurance Surety Bonds, Account Payee Demand Draft or Banker's Cheque or Fixed Deposit Receipt from any of the Commercial Banks towards EMD in favour of **Executive Engineer (E), CCW AIR PB(BCI), Mumbai-20**, receipt for deposition of original EMD to the Executive Engineer (E), CCW, AKASHVANI, PB(IPSB), Mumbai-20 or division office of any Executive Engineer (C/E), Civil Construction Wing, Akashvani, within the period of bid submission and other documents as specified. The FDR shall be accepted only if it is valid for a period of six months or more after date of opening of the Tender.
- Detailed procedure can be seen in the CPWD-6 for e-Tendering
- Contractors, who are not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the said website
- The intending bidder must have valid **Class-III** Digital Signature to submit the bid.
- On the date of opening of the Bid, the bidder can login and see the bid opening process. After opening of Bids he will receive the competitor bid sheets.
- Bidder can upload documents in the JPG or PDF format.
- SC/ST bidders enlisted under Class-V category are exempted from processing fee of e-Tender payable to M/s. C1 India Pvt. Ltd.

3	<p>Certificates of Work Experience, of similar nature in Para 1.2 of Form CPWD-6.</p> <p>The agency should have experience of having successfully completed [similar works means SITC AC Plant] in Central Government, State Government, PSUs and other Government Local bodies, otherwise TDS Certificate is required against the eligible work during last seven years ending last day of the month previous to the one in which applications are invited. (To avoid delays in getting the completion cost verification from the project authorities, TDS certificate including BOQ of Final bill is desired, but not essential for tendering purposes. Full credentials of the project authorities e.g. email, ID, complete postal address, Phone no. etc. are required for verification purposes.)</p> <p>Three similar completed works each of value not less than 40% (12.20 Lakhs) of the estimated cost put to tender with capacity of individual AC Plant being 44 TR of the individual capacity (rounded off to next available higher capacity) or Two similar completed works each of value not less than 60% (18.30 Lakhs) of the estimated cost put to tender with capacity of individual AC Plant being (44 TR) of the individual capacity or One similar completed work of value not less than 80% (24.40 Lakhs) of the estimated cost put to tender with capacity of individual AC Plant being (44 TR) of the individual capacity of the equipment</p>
4	<p>Copy of Certificate of Registration for GST OR</p> <p>UNDERTAKING: If work is awarded to me, I/we shall obtain GST registration certificate as applicable within one month from the date of receipt of award letter or before release of any payment by CCW AKASHVANI, whichever is earlier, failing which I/we shall be responsible for any delay in payments which will be due towards me/us on account of the work executed and/or for any action taken by CCW AKASHVANI or GST department in this regard.</p>
5	Copy of Acknowledgement of up to date filed return of GST i.e. Up to June 2023
6	<p>Copy of Affidavit on their letterhead as per Para 1.2.2 and 9 of Form CPWD 6</p> <p><i>"I/We undertake and confirm that eligible similar work/s has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in CCW AKASHVANI in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee. The certified copy of all the scanned and uploaded documents specified in the Press Tender Notice/NIT shall be deposited by me/us with the Executive/Executive Engineer (Electrical), Civil Construction Wing, Akashvani, Mumbai-20, in case I/we become the lowest tender within a week of opening of the financial bid, otherwise the Department (CCW-AKASHVANI) may reject the tender and take action to debar me/us from tendering in CCW AKASHVANI for a period of three years and can write to the Competent Authority for cancellation of my/our enlistment</i></p>
7	Copy of Certificate or Registration of EPF and ESI should be uploaded or in case the contractor feels that the EPF and ESI Acts are not applicable in his case and such registration certificates are not required for the work he shall upload the necessary undertaking to this effect
8	Bank Solvency Certificate OR Net worth Certificate certified by the Chartered Accountant with Unique Document Identification Number
9	Valid Enlistment Order of the Contractor, if any

DEFINITIONS:

- **C1 India Pvt. Ltd.:** Service provider to provide the e-Tendering Software.
- **Prasar Bharati e-Procurement Portal:** An e-tendering portal of Prasar Bharati introduced for the process of e-tendering which can be accessed on <https://prasarbharati.eproc.in>.

I. ACCESSING / PURCHASING OF BID DOCUMENTS :

- It is mandatory for all the bidders to have Class-III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) from any of the licensed Certifying Agency under CCA, Ministry of Electronics and Information Technology, Government of India to participate in e-tendering portal of Prasar Bharati. Bidders can see the list of licensed CA's from the link www.cca.gov.in C1 India Pvt. Ltd. also facilitate Class III Digital Signature Certificate (With Both DSC Components, i.e. Signing & Encryption) to the bidders. Bidder may contact C1 India Pvt. Ltd. at mobile no. +91-8130606629 for DSC related queries or can email at vikas.kumar@c1india.com
- To participate in the e-bid, it is mandatory for the Applicants to get themselves registered with the Prasar Bharati e-Tendering Portal (<https://prasarbharati.eproc.in>) to have a user ID & Password which has to be obtained by submitting a non-refundable annual registration charges of Rs. 450/- plus 18% GST through **online** mode (net banking/debit card/credit card). Validity of Registration is 1 year.
- The amendments / clarifications to the tender, if any, will be posted on the Prasar Bharati e-Tendering Portal (<https://prasarbharati.eproc.in>).
- To participate in bidding, bidders have to pay Tender Processing Fee according to the Tender Value (per Tender per Bid through online mode viz.

Less than or Equal to Rs. 10 Lakhs	Rs. 475.00 + 18 % GST
More than 10 Lakhs but Less than or equals to 50 Lakhs	Rs. 925.00 + 18 % GST
More than 50 Lakhs	Rs. 1150.00 + 18% GST

- If in case, for any particular Tender, Estimated Cost is unknown to Prasar Bharati, the Processing Fee would Rs. 1150.00 + 18% GST
- The Bidder may modify or withdraw their bid after submission prior to the Bid Due Date. No Bid shall be modified or withdrawn by the Bidder after the Bid Due Date and Time.
- Both 'EMD' and 'Tender Document Fee', if any, are mentioned in individual tender document published at Prasar Bharati e-Tendering Portal (<https://prasarbharati.eproc.in>).
