- (ii) Casual Assignee's Fee and Nature of job/ Qualification & Mechanism for their Empanelment [as per Annexure-II (Part-A & Part-B)]
- These rates will come into effect from the date of issuance of this order and shall be applicable to all programme proposals approved after the date of issuance of this order.
- Heads of Programme should particularly acquaint themselves with Approval mechanism & relevant information as well as SI. No. 48 [Title: Travelling, Accommodation & Food] of Annexure – I and Mechanism for Empanelment of Casual Assignees of Annexure – II [Part-A].
- 4. Revision of rates with regards to Clause 7 of Revised fee structure (2012) for performing artists and assignees of Doordarshan titled Doordarshan Sports commentators/anchors/Statisticians/Scorers will be taken up separately and will remain applicable until rates are revised.

- **5.** With regards to Casual Assignees (Annexure-II), Heads of Programme should ensure the following:
 - a. Casual Assignees to be booked only for Programme Production, Programme Co-ordination and Programme Management related work.
 - b. Assignees should be booked for specific assignment as per functional requirement.
 - c. Any casual assignee can be booked for maximum 7 assignments in a month and not exceeding 120 working days in a year. One assignment cannot take more than 3 days under any circumstances.
- 6. Heads of Programme are advised that due diligence may be accorded while booking artists and casual assignees so that creative & talented artists/assignees of diverse fields are engaged.
- 7. This issues with the approval of the Competent Authority.

Mechanism for Empanelment of Casual Assignees

A. Casual Assignees

A.1 Casual Assignees booked in any categories that are mentioned in ANNEXURE–II (Part-B) (Casual Assignee's Fee and Nature of job/ Qualification) may be engaged for a maximum 7 assignments in a month and not exceeding 120 working days in a year. One assignment cannot take more than 3 days under any circumstances. Casual Assignees shall have no claim either implicit or explicit, for his/ her absorption or regularization in Prasar Bharati.

A.2 A mechanism has been created to empanel casual assignees. However this new mechanism shall be in force from the date of notification of this rate card and shall be applicable to new empanelment. All the previous empanelment shall continue, if so desired, by Head of Programme.

B. How to decide on requirement of Casual Assignees?

B.1 Programme officer responsible for a particular programme/assignment/ task/project /section may raise the request for booking of casual assignee(s) on assignment basis. Such request shall be made to Head of Programme of concerned Kendra /Channel /PGF/ Platform. Head of Programme shall decide upon the need to book the casual

assignee(s) in any category as per ANNEXURE-II (Part-B) either on request on concerned Programme officer or on its own.

C. How to empanel Casual Assignees?

C.1 Head of Programme (HoP) of concerned Kendra/Channel/PGF/ Platform may empanel sufficient number of casual assignees as per requirements for duration of 02 year from Date of Empanelment. The empanelment shall be done by Head of Programme based on recommendations of Committee at Kendra /Channel /PGF/ Platform.

D. What shall be the role of Committee?

D.1 From time to time, for empanelment of casual assignees, a 03(three) members Committee shall be constituted by Head of Programme of concerned Kendra/Channel/PGF/Platform comprising of Programme officers of the concerned Kendra/Channel/PGF/Platform.

D.2 Head of Programme of concerned Kendra/Channel/PGF/Platform, in consultation with committee, shall issue the notice stating number of candidates to be empanelled, Fee, qualification and terms & conditions. Committee will conduct the entire end to end empanelment process of casual assignees in accordance with ANNEXURE–II (Part-B) including interviews/proficiency test (wherever required). In case of shortage of manpower, additional officer from

nearby Kendra may also be assigned after approval from concerned Zonal Head (Content Ops) or in his/her absence upon approval by Director General, Doordarshan through Officer-in-charge of Programme Section at DG:DD.

D.3 Due publicity to the notice shall be given through website/scrolls/social media/Public Service Announcements and/or any other suitable medium. Committee shall recommend a list of casual assignees to be empanelled to Head of Programme. The date of acceptance of recommendation by Head of Programme shall be the Date of Empanelment. It is expected to empanel young and talented candidate with diverse skills. Upon empanelled, casual Assignees can be booked as per requirement of concerned Kendra/Channel/PGF/Platform, on assignment basis, for Programme related activities.
