6. Qualification	Diploma/Degree in the field of Electronics, Communication, Computer/Information Technology, Photography/Cinematography or equivalent.
7. Experience	i. At least 1 year of Experience of operation and maintenance of Camera, switching, power supply and Broadband or similar setup.
8. Age	Below 35 years as on date of notification. Relaxation in Upper age limit by 10 years to:- "The casual assignees and /or contractual engagees should have been engaged with Prasar Bharati continuously for atleast 5 years."
9. Nature of Duties	(i) Operation of Setup for Live Telecast/ Streaming/ of Aarti from Shri Ram Janmbhoomi Mandir Ayodhya. (ii) The responsibility will include operation of Vision Mixer, Audio Console, PTZ Camera and its Controls, Encoders and accessories associated for telecast of Aarti. Alignment of remote operated cameras, its periodic cleaning, placement of microphone, supervision of Broadband functionality and basic troubleshooting of switching on of equipment will also form the part of duty. (iii) The Telecast Executive will be required to work in a shift as per the decision of the officer In charge of the Project and the Officer on Duty at Doordarshan/AIR establishment at the remote end of the feed reception. The person may also be required to feed the signal to Video walls installed by the Trust as per the instruction of the Officer In Charge of DD/AIR. The on duty person would be required to maintain a log book for the transmission details and faults or breakdowns , if any.

10. The terms and conditions of the engagement are as given under:

- i. The services will be purely on contractual basis. The persons engaged shall have no claim either implicit or explicit, for his/ her absorption or regularization in Prasar Bharati.
- ii. The person will be engaged on full time basis and will not be allowed to take up any other assignment during the period of contractual engagement.
- iii. Persons engaged on contract basis can be assigned additional task apart from the specific tasks for which they are engaged.
- iv. Period of engagement shall initially be for two years with an annual appraisal which may be extendable based on requirement of the organization and performance review.
- v. The engagement can be discontinued/ terminated with one- month notice or one month's salary in lieu thereof by either side without assigning any reason.
