3. **Place of work:** Hyderabad
4. **Duration of engagement:** Two years
5. **Consolidated monthly remuneration:** ₹ 80,000 – 1,25,000/- (Negotiable)

  - i. Degree/ PG Diploma in Journalism/ Mass Communication/ relevant field from recognized university/ institute
