## CONDITIONS:

- The work shall be carried out as per CPWD Specifications, 2019 Vol. I & II with upto-date correction slips and as per direction of Engineer-in-charge;
- Time limit for completion of work is 15 (Fifteen) days.
- Quoted rates shall be inclusive of all taxes and levies payable under the respective statutes including GST, nothing extra will be paid on any account;
- The Agency shall visit the site of work before quoting, as no extra payment will be made on any such as extra Thickness of base course/depths and all height of buildings etc.
- All type of security measures / precautions of labour shall be responsibility of agency during execution of work. No extra payment will be made on any account.
- If the work is prolonged beyond stipulated time the penalty shall be imposed @ Rs. 2500. 00 per
- The agency will be responsible for any defect for a period of 12 (twelve) months after issuing completion certificate for the work by Engineer-in-charge & client department.
