

The Structural Engineer will design


1. The structural and working drawing as per details & specification provided by the department however there may be minor change in requirement during execution which Architect/ consultant will do without any extra cost.
2. The time allowed for carrying out the work in 20 days. The date of start will be from the next day from the date of issue of work order.
3. Architect/ consultant will provide soft copies and hard copies as per requirement for all the calculations/ input drawings.
4. The quotation will be issued to only those architectural firms/consultants who will produce copy of experience certificate (Government/private) for completion of at least one work of steel tower design for 40 meter height in any sector.
5. The work shall be done as per requirement given by Engineer-in charge.
6. The payment will be released only after architectural firm/ consultant register their GST as per applicable laws otherwise exempt.
7. Rates are inclusive of all taxes & fee and nothing extra will be paid. The TDS/ taxes as applicable will be deducted as per rule.
